Subject: Violation of PPRA Rules 2004, Executive Engineer, Hyderabad Electric Supply Company (HESCO), Civil Work Division HESCO, Hyderabad's Tender Notice for Construction & Establishment of Transformer Reclamation Workshop.

Dear Sir,

This is with reference to your tender notice appeared in daily 'Dawn' newspaper on 3rd February, 2024. The said advertisement is in violation of Public Procurement Regulatory Authority (PPRA) Rules 2004, Rule 28 'Opening of Bids'.

In the tender notice, the date for receiving of tenders in given as 23.02.2024 while the date for opening of tenders is kept on 26.02.2024. As per PPRA 2004, Rule No. 28, the opening and the closing of bids should be on the same date. Hence, it is a violation PPRA Rule No 28.

The Rule is quoted below for your reference;

28. Opening of bids.- (1) The date for opening of bids and the last date for the submission of bids shall be the same. Bids shall be opened at the time specified in the bidding documents. The bids shall be opened at least thirty minutes after the deadline for submission of bids.

Executive Engineer, HESCO is requested to rectify the violation and issue corrigendum in accordance with PPRA 2004 to avoid mis-procurement under Rule 50.

This is to clarify that Transparency International Pakistan is not a complainant, it acts as a whistleblower and operate under Article 19-A, of the Constitution of Pakistan which gives the right to public to know how government is being run by public officers. Article 19-A makes the right to access of information pertaining to a public authority a fundamental right, and a three member bench in case of Mukhtar Ahmad Ali vs the Registrar, Supreme Court of Pakistan, Islamabad, headed by Chief Justice Qazi Faez Isa in the landmark judgment on 16 October 2023, in CP No. 3532/2023, has declared that

"What previously may have been on a need-to-know basis Article 19A of the Constitution has transformed it to a right-to-know, and the Access to information is no longer a discretion granted through occasional benevolence, but is now a fundamental right available with every Pakistani which right may be invoked under Article 19A of the Constitution"
