Executive Summary

In 2023, Transparency International Pakistan (TI Pakistan) made significant strides in advancing its mission to combat corruption and promote transparency at both grassroots and national levels. The organization engaged with 547 citizens, including 178 females, through impactful Mobile Legal Advice Camps held across various districts of Pakistan, in alignment with its core values to provide free legal advice to the citizens. The commitment to combating corruption at the grassroots level was further emphasized through a series of eight enlightening workshops on Right to Information (RTI) laws, where 365 citizens, including 84 females, were trained. These workshops aimed to enhance awareness and practical application of RTI laws, empowering citizens to actively participate in the fight against corruption.

In its relentless pursuit of transparency and accountability, Transparency International Pakistan (TI Pakistan) actively focused on the implementation of PPRA Rules. Throughout the year, the organization sent 227 cases/complaints to authorities, addressing instances of potential violations of PPRA Rules, further underscoring its commitment to fostering ethical practices and good governance.

TI Pakistan's collaboration with partner organizations resulted in the successful organization of four "Citizens' Meeting with Local Government Representatives" in Balochistan, Punjab, and Sindh, engaging 335 citizens, including 56 females. These sessions facilitated dialogue and advocated for citizen engagement in local governance, holding representatives accountable.

The organization launched "Strengthening Transparency & Integrity in Climate Governance" project which seeks to address the endemic of corruption by working with different groups and stakeholders to ensure that climate action in Pakistan is inclusive and transparent. TI Pakistan has established four Civil Society Networks in the provinces, fostering collaboration among civil society actors, UN bodies, and government stakeholders. Training workshops and community dialogues on climate change were conducted, engaging 196 citizens, including 75 females in workshops, and 382 citizens in community dialogues.

TI Pakistan demonstrated a commitment to gender empowerment by conducting ten community dialogues and four workshops on Gender and Corruption, specifically targeting the involvement of women in anti-corruption efforts. A significant number of 751 females actively participated in these sessions. The organization further organized "Provincial Punjab Conference on Tackling Corruption to Enhance Gender Equality," bringing together experts, policymakers, and civil society representatives to strategize ways to empower women in the fight against corruption and promote gender equality.

Youth engagement remained a focal point, with 1,127 individuals, including 382 females, trained in workshops and conferences.

TI Pakistan actively participated in COP28, addressing critical issues in side events and emphasizing the role of young people in promoting transparent, accountable, and good governance.

TI Pakistan's multifaceted efforts extended to training 129 government officials on Anti-Corruption Mechanism and Right to Information Laws. Additionally, 04 workshops on Sustainable Development Goals (SDG16) were conducted, involving students and faculty in understanding sustainable development.

On International Anti-Corruption Day, TI Pakistan organized seminars and walks across the country, mobilizing 1,104 citizens, including 252 women. The National Corruption Perception Survey 2023, involving 1,600 respondents, provided insights into citizens' perceptions of corruption. The organization also released reports on the state of implementation of online proactive disclosure provisions and a civil society parallel report on Pakistan's progress towards four SDG targets related to anti-corruption and transparency. These reports aimed to provide independent assessments of the country's anti-corruption efforts in the context of the 2030 Agenda for Sustainable Development.

As TI Pakistan moves forward, the focus will remain on empowering marginalized communities, especially women, and strengthening accountability mechanisms within government institutions. Continued research and advocacy, coupled with active citizen engagement, will be crucial in driving lasting change and building a corruption-free Pakistan.








Problem Sector












LAUNCHING OF CLIMATE GOVERNANCE INTEGRITY PROGRAMME (CGIP)



Pakistan which is rated as the 5th most vulnerable country to be impacted by climate change and the least well-equipped country to respond to climate risks. In June 2022, Pakistan endured severe monsoon which saw area-weighted rainfall 67 per cent above normal levels in that month alone. This has caused widespread flooding and landslides, with severe repercussions for human lives, property and infrastructure in Pakistan.

Given Pakistan's limited fiscal resources, significant international support and private investments have been promised for a comprehensive and resilient recovery. However, the adverse impacts of climate change and the humanitarian efforts to overcome the same are further accelerated by corruption that takes place in multiple forms.

To address this, in 2023, TI Pakistan launched the "Strengthening Transparency & Integrity in Climate Governance" project. It seeks to address the endemic of corruption by working with different groups and stakeholders to ensure that climate action in Pakistan is inclusive and transparent and the climate governance frameworks at federal and provincial levels are effective and responsive to the community needs.

The Program (CGIP) aims to strengthen integrity and inclusiveness in climate governance and its main objects are:

- Make Climate Action Transparent and Inclusive
- Improve Climate Accountability
- Safeguard Climate Funding
- Protect Communities

ADVOCACY AND LEGAL ADVICE CENTER - MOBILE ALAC

Transparency International Pakistan continued its commitment to delivering free legal advice to the throughout citizens 2023. In collaboration with partner organizations, TI Pakistan organized eight impactful Mobile Legal Advice Camps in various districts, covering all provinces aligning with its mission to combat corruption at the grassroots level.

The primary aim of these legal advice camps remained consistent: to provide free guidance to victims and witnesses of corruption, empowering them to seek redress for their complaints.

Diverse range of citizens, including females, actively participated in these camps, availing themselves of the opportunity to receive valuable legal advice for addressing their specific problems. Legal experts extended their support to the complainants, resulting in the registration of numerous complaints.

These Mobile ALAC camps were strategically conducted in:

- In Province Sindh: Badin, Hala
- In Province Punjab: Vehari, Jhang, Khanewal
- In Province KP: Takht Bhai, Swat
- In Province Balochistan: Kalat

The issues raised by citizens encompassed a wide spectrum, from concerns about the sewerage system, online fraud, and the availability of public amenities to challenges like doctor shortages in public hospitals, property disputes, violations women rights, water supply issues, tube-well malfunctions, electricity problems, and the registration of people with special needs.

Citizens expressed gratitude for the impactful efforts made by Transparency International Pakistan in organizing free legal advice camps, providing a platform to highlight their concerns at the provincial level. The free legal advice camps not only facilitated immediate problem-solving but also played a crucial role in enhancing citizens' awareness of their fundamental rights.

In 2023, Transparency International Pakistan organized a series of eight enlightening workshops, focusing on Right to Information (RTI) laws to foster a culture of transparency and accountability.

These workshops spanned diverse regions, empowering citizens with knowledge and understanding of their right to access information.

The workshops were strategically conducted in:

- Sindh: Khairpur
- Punjab: Layyah, Sialkot
- Balochistan: Khuzdar, Sohrab
- Khyber Pakhtunkhwa (KP): Kohat, Malakand

The workshops were designed with the objective of enhancing citizens awareness regarding Access to Information laws in Pakistan. Participants were guided on the practical application of Right to Information (RTI) laws, empowering citizens to actively engage in the fight against corruption. Comprehensive training sessions delved into the intricacies of RTI laws, elucidating the clauses and procedures necessary for obtaining information from public bodies.







In 2023, Transparency International Pakistan, in collaboration with partner organizations, hosted four "Citizens' Meeting with Local Government Representatives" in Kalat and Lasbela. Balochistan; Sahiwal, Punjab; and Mirpurkhas, Sindh. The sessions aimed to facilitate dialogue between citizens and local government representatives. addressing challenges and advocating citizen local engagement in governance.

Presentations covered the local government structure, emphasizing participation and effective citizen governance. Local govt representatives expressed the effectiveness of direct contact and highlighted the system's for empowerment. potential The events fostered awareness, empowering citizens and fostering engagement in local governance.

TI Pakistan encourages grassroots social accountability through citizen meetings with local government representatives, emphasizing the vital role of local governance in fostering democratic participation and addressing community needs directly.







Section 2: Capacity Building of Government Officials on Anti-Corruption Mechanisms and Right to Information

Training of Public Officials on Section 5, Proactive Disclosure, Federal Right of Access to Information Act 2017



On November 20, 2023, TI Pakistan organized training of Public Information Officers under Section 5 Proactive Disclosure, Right of Access to Information Act 2017, in collaboration with Pakistan Information Commission at a local hotel in Islamabad.

The primary objective was to highlight key elements of proactive disclosure. It sought to increase awareness and build the capacity of Public Information Officers to ensure adherence to the Right of Access to Information Act 2017.

The training was attended by designated PIOs of various departments of the Federal Government.

Notable speakers, including Advocate Daniyal Muzaffar, Legal Advisor at the Board of Trustee, TI Pakistan, Mr. Shoaib Ahmed Siddiqui, Chief Information Commissioner at the Pakistan Information Commission, Mr. Kashif Ali, Director of TI Pakistan, Executive Mukhtar Ahmed Ali, Executive Director of the Centre for Peace and Development Initiatives and former Commissioner of the Punjab Information Commission, as well as Mr. Muhammad former Chief Information Commissioner addressed various aspects of the Federal RTI Act 2017 during the training.

Training of Public Officials on Section 6, Proactive Disclosure, Sindh Transparency and RTI Act 2016



International Transparency Pakistan conducted a training session for Public Information Officers (PIOs) in Karachi under Section 6 Proactive Disclosure, Sindh Transparency and RTI Act 2016. Over 50 government department PIOs attended, and speakers, including Chairman TI-Pakistan Justice (R) Zia Perwez and Executive Director, Mr. Kashif Ali, highlighted the significance of proactive disclosure in RTI laws. The training covered various aspects of proactive disclosure, emphasizing the future role of PIOs in effective RTI implementation. The other speakers including Dr. Nausheen Wasi, Assistant Professor of International Relations at the University of Karachi and member of the Board of Trustees of TI Pakistan; Dr. Jawaid

Ali, Chief Information Commissioner, Sindh Information Commission; Advocate Saima Agha, Information Commissioner, Sindh Information Commission; Mr. Shahid Jatoi, Information Commissioner, Information Commission; Mr. Nadeem Ur Rehman, Secretary Information. Government of Sindh. Dr. Raza Gardezi, an RTI expert, delved into key provisions and obligations of public bodies under the Sindh Transparency and RTI Act 2016, providing detailed training on the role of PIOs.

Justice (R) Zia Perwez, Chairman of TI Pakistan, highlighted the significance of RTI legislation and hoped that the training would enhance their understanding and enable effective handling of RTI requests.



TRAINING OF PUBLIC OFFICIALS ON SOCIAL ACCOUNTABILITY AND ANTI-CORRUPTION MECHANISMS

The workshop addressed challenges faced by public officials and emphasized the role of transparent administrations in promoting good governance. The interactive session showcased participants' enthusiasm, concluding with the distribution of certificates to acknowledge their active engagement and attendance.

Section 3: Gender and Corruption: Women **Empowerment** Through Participation in **Decision Making**



Transparency International Pakistan (TI Pakistan) successfully organized the "Provincial Punjab Conference on Tackling Corruption to Enhance Gender Equality" at Avari Hotel in Lahore on September 19th, 2023. The event brought together renowned experts, policymakers, and civil society representatives to discuss and strategize ways to empower women in the fight against corruption and promote gender equality.

Community Dialogue on Women Empowerment through Awareness of Their Rights

TI Pakistan conducted ten Community dialogues on women empowerment and awareness of their rights across various regions in Pakistan. In Punjab, dialogues took place in Lahore, Qasoor, Nankana, and Sheikhpura, while in Sindh, sessions were arranged in Larkana, Mirpurkhas, and Sanghar. Khyber Pakhtunkhwa witnessed dialogues in Haripur and Mansehra, and in Balochistan, a dialogue was held in Pishin. These initiatives aimed to foster awareness and empowerment among women, promoting a deeper understanding of their rights within different communities across the country.











Workshops on Gender and Corruption

TI Pakistan's decision to conduct four workshops on Gender and Corruption, specifically focused on empowering women in the fight against corruption, highlights the critical importance of addressing aender dvnamics in combating corrupt practices. By holding these workshops in diverse locations—Mithi, Sindh; Gujranwala, Punjab; Quetta, Balochistan; and Nowshera, Khyber Pakhtunkhwa—the initiative recognizes the need

for comprehensive, nationwide approach. The workshops serve as a strategic platform to not only raise awareness about gendered dimension of corruption, gendered impacts but also to equip women with the knowledge and tools necessary to actively participate in anti-corruption efforts. It acknowledges the pivotal role women plav promoting transparency and accountability, emphasizing their empowerment as a key element in fostering a corruption-free society.

Provincial Khyber Pakhtunkhwa Youth Integrity, Leadership & Anti-Corruption Conference





On August 8, 2023, Transparency International Pakistan organized the "Khyber Pakhtunkhwa Youth Integrity, Leadership & Anti-Corruption Conference" on August 8, 2023, at Serena Hotel, Peshawar. The conference aimed to engage and inspire youth in the fight against corruption, with 140 participants from 14 universities in Khyber Pakhtunkhwa attending the conference.

Speakers included Advocate Hasmat Habib, Board of Trustee TI Pakistan, Mr. Kashif Ali, Executive Director, Transparency International Pakistan), Mr. Nisar Ahmad Khan (Director, FIA KP), Mr. Mian Muhammad Waqar, Director Awareness & Prevention (A&P) wing, NAB KP, Mr. Saayad Saadat Jehan (Deputy Director, KP Information Commission), Syed Sabir Ali Shah (Project Manager, UNDP SDG Unit), Syed Raza Ali (CEO, Peace and Justice Network) and Ms. Amna Kausar (Senior Projects Manager, PILDAT Pakistan) spoke during the conference.

Discussions covered topics including the Right to Information Act, youth-driven governance for SDGs, youth leadership and integrity, democracy and rule of law, and accountability procedures by NAB. The event fostered insightful discussions and engaged participants in breakout activities, promoting transparency, accountability, and youth empowerment in Pakistan.







Workshop: Youth and Anti-Corruption Efforts





Youth Engagement, Leadership and Participation for Transparent and Inclusive Governance

Throughout 2023, Transparency International Pakistan (TI-Pakistan) embarked on a mission to empower young people across Pakistan, conducting impactful workshops in Thatta and Umerkot (Sindh) and Gujranwala and Multan (Punjab). These insightful sessions aimed to equip young minds with the knowledge and skills needed to actively participate in building a more transparent and inclusive future.

Each workshop delved into key topics like leadership skills, understanding the respective provincial Youth Policies and navigating the Right to Information (RTI) laws. These sessions were meticulously designed to include dedicated breakout groups, fostering focused discussions and enabling participants to formulate concrete recommendations for improving the relevant Youth Policies.

Throughout the workshops, the emphasis remained on promoting education, advocating for transparent policies, and encouraging youth-led initiatives to combat corruption. These sessions also facilitated valuable interactions between students and government officials, creating a platform for open dialogue on critical issues impacting their communities.

Section 5: Sustainable Development Goals (SDGs)

Capacity-Building Training Workshop: Sustainable Development Goals (SDG16: Peace, Justice, And Strong Institutions)

Capacity Building Workshop at Shaikh Ayaz University, Shikarpur

TI Pakistan held a training workshop on SDG16 (Peace, Justice & Strong Institutions) at Shaikh Ayaz University, Shikarpur, Sindh. Over 120 students and faculty members attended, aiming to understand sustainable development and their role in achieving it.

A key highlight was the signing of a MoU to establish a Youth Integrity Club (YIC). This platform will provide students with training on transparency, governance, and SDGs.

Mr. Kashif Ali, TI Pakistan's Executive Director, spoke about SDG16 and its focus on peace, justice, and accountable institutions. He encouraged students to use YIC to push for SDG16 implementation in Pakistan.

Presentations on Sindh RTI Act and leadership for SDGs further engaged the audience. Dr. Saqib Mahar, University Registrar, concluded by emphasizing the importance of youth in driving progress towards a sustainable future.

Certificates were awarded, followed by networking opportunities, enriching the experience for all participants.



SDG16: Peace, Justice, And Strong Institutions

Goal 16 is about promoting peaceful and inclusive societies, providing access to justice for all and building effective, accountable and inclusive institutions at all levels. People everywhere should be free of fear from all forms of violence and feel safe as they go about their lives whatever their ethnicity, faith or sexual orientation.





Youth Awareness and Capacity Building Workshop on Sustainable Development Goal 16 (Peace, Justice & Strong Institutions)

Capacity Building Workshop at Sindh Madrasa ul Islam University, Karachi

Transparency International Pakistan held a workshop at Sindh Madrasa ul Islam University, Karachi on March 20th, 2023, raising awareness among 200 students (90 females) about SDGs and youth's role in SDG 16 (Peace, Justice & Strong Institutions). Dr. Kamran Ahmed (Thinkers Tribe) emphasized Pakistan's economic crisis highlighting SDGs' importance. encouraged research academic contributions, stressing universities' role in promoting SDGs. Mr. Avinash Advani (Shahid Afridi Foundation) emphasized brainstorming youth input for Goal implementation. 16 He acknowledged Pakistan's youth potential, encouraging them to share their ideas.

Mr. Kashif Ali (TI Pakistan) presented SDGs, discussing Goal 16's targets and TI Pakistan's civil society shadow report findings. He highlighted that SDGs provides a historic opportunity: to realize the 2030 Agenda for Development Sustainable secure a better future for all of us. But this inspiring vision is challenged by risks, the most serious of which is that all 17 unanimously adopted Sustainable Development Goals (SDGs) could be severely undermined by corruption.

Mr. Ashfaque Ahmed (TI Pakistan) briefed on Right to Information Laws, explaining their background and importance. Dr. Hashim Zuberi (SMI University) stressed the environmental impact and need for youth's role in achieving SDGs through conservation measures.

Students worked in breakout groups after presentations, formulating ideas on their role in promoting sustainable development.

Dr. Jamshed Adil (SMI University) thanked TI Pakistan, emphasizing the need for more such workshops. He encouraged students to actively participate in promoting SDGs.

The workshop concluded with a refreshment session for all participants and guests.





Panel Discussion: SDG-16, Peace, Justice, & Strong Institutions in Greenwich University



Transparency International Pakistan, UNDP, and Thinkers Tribe convened a panel discussion at Greenwich University Karachi on SDG16 - Peace, Justice, and Strong Institutions.

Representatives from UNDP, academia, and NGOs explored the goal's importance for sustainable development and how youth can contribute.

Key points:

- Mr. Kashif Ali (TI Pakistan):
 Emphasized combatting corruption through strong anti-corruption laws, whistleblower protection, and transparent governance.
- Mr. Ahmad Hasan (UNDP): Highlighted SDG16's role as a cornerstone for overall sustainable development and encouraged student research and initiatives.

- Ms. Sabeena Abbasi: Stressed the importance of quality education for empowering citizens, particularly vulnerable groups, in accessing justice and upholding the rule of law.
- Ms. Saima Khuhro: Emphasized the crucial role of civil society, NGOs, and individuals in implementing and monitoring SDG16 at all levels, urging youth to leverage social media for awareness.
- Mr. Ali Jillani (Greenwich University): Underlined the critical role of education and awareness campaigns in promoting SDG16 and highlighted universities' contributions through research and policy advocacy.

Section 6: Climate Governance Integrity Programme (CGIP)











Executive Director, TI Pakistan Kashif Ali spoke at two side events on "Equity and Justice in the Financing Mechanism of Loss and Damage to meet the Needs of the Communities" and "The Global Stocktake" and Climate Accountability: Unlocking Finance and Action".



The discussions highlighted how Conflict of Interests and Undue Influence in climate finance can undermine the fair allocation of resources, diverting funds towards projects that may not effectively address climate issues. The side events emphasized that establishing clear institutional accountability mechanisms for climate finance enhances trust among stakeholders, promotes adherence to climate goals, and ultimately contributes to the success of global efforts in addressing climate change.

MEETING WITH FEDERAL SECRETARYCLIMATE CHANGE



Transparency International Pakistan Executive Director and Project Coordinator, Climate Governance Integrity Program had a meeting with the federal secretary Ministry of Climate Change to discuss recommendations on strengthening integrity and inclusiveness in Pakistan's climate response. TI Pakistan is advocating for the establishment of a national tracking system to disclose information pertaining to climate finance in Pakistan, its utilisation and compliance with procurement rules in climate related projects.

CIVIL SOCIETY NETWORKS ON TRANSPARENT AND INCLUSIVE CLIMATE GOVERNANCE



TI Pakistan established 04 Civil Society Networks on Transparent and Inclusive Climate Governance in Sindh, Punjab, Khyber Pakhtunkhwa and Balochistan The networks provinces. brought together provincial civil society actors, UN bodies and the government stakeholders on one table to highlight the need for mechanisms accountability within provincial climate policies to ensure that climate action is transparent and inclusive.

The networks have reviewed climate policies, identified gaps and developed recommendations focusing on enhancing inclusiveness and integrity in climate action in Pakistan. TI Pakistan has advocated with relevant line departments for implementation.

SUCCESS STORY

One of the recommendations was the appointment of a Public Information Officer (PIO) who would serve as a bridge between the government, funding agencies, and the public, ensuring that information about climate initiatives was readily available to ensure citizens oversight in climate action and allocation of funds.

Due to consistent advocacy of TI Pakistan, on 13th of June, 2023, the ministry of Environment, Climate Change & Coastal Development Department, Sindh appointed (PIO) officer under the Section 7 and also uploaded the details on their website.



Transparency International Pakistan organized 04 Training Workshops on 'Climate Change Impacts, Mitigation, Adaptation, Risk Reduction & Social Accountability Tools" to enhance communities participation in climate planning and decision making. These workshops were organized in Districts of Sanghar, Kot Addu, Swat and Naseerabad. These districts are some of the most vulnerable to climate change and one of the worst affected during floods 2022.

The workshops were attended by local community members, youth, civil society representatives, representatives of DDMAs, climate change experts and journalists. During the workshops, the speakers gave awareness sessions on climate mitigation and adaptation.

Speakers from District Disaster Management Authorities (DDMA) and climate experts conducted the sessions on basic concepts and terminologies in disaster management, climate disaster risk, mitigation and risk reduction. They provided basic awareness on disaster, hazard, and disaster risk reduction strategies.

Participants were asked to identify between vulnerability and capacity from their daily life practices. Representatives from DDMAs also spoke on the importance of District Disaster Management Committee and coordination mechanisms among the institutions during any disaster.







Transparency International Pakistan organized 07 Community Dialogues in the climate-vulnerable districts of Sindh, Punjab, Khyber Pakhtunkhwa and Balochistan. The purpose of these dialogues was to raise awareness against environmental corruption among marginalized communities, fostering citizen participation in climate decision-making and planning.

The dialogues were attended by the members of the communities and civil society, from climate vulnerable tehsils, along with members of the district administration, representatives of EPA and DDMAs.

These dialogues were organized in Sujawal and Jacobabad, Nowshera, Swabi and Jaffarabad where speakers conducted awareness sessions on climate change, climate mitigation, Provincial Right to Information Acts, social accountability tools, climate vulnerabilities of districts, gendered vulnerabilities to climate change and role of local administration during emergencies.







TI Pakistan, through its social media ran a public campaign on climate change which aimed to inspire tangible actions, encouraging individuals and communities to embrace eco-friendly habits and contribute to a resilient future.

These campaigns served as a platform for disseminating crucial information on climate change. By fostering a sense of responsibility and empowerment, we aimed to mobilize a broad spectrum of society to take meaningful steps towards reducing carbon footprints and embracing renewable energy sources. The campaign reached out to more than 3000 people effectively raising awareness on climate change, its effects and citizens participation in the climate action.

On International Anti-Corruption Day, December 9, 2023, Transparency International Pakistan organized seminars and walks across the country. The objective was to mobilize diverse stakeholders and unite efforts against corruption.

A total of 22 events were organized in 22 districts across all the four provinces of Pakistan in which around 1,104 citizens including 252 women participated.

A diverse representation of government officials, civil servants, law enforcement officers, media representatives, the private sector, civil society,





Ensuring transparent and accountable use of funds and community participation in climate planning and decision making is essential to enhance the resilience of communities to climate impacts.

Section 8: TI-Pakistan's Survey and Reports

TI PAKISTAN NATIONAL CORRUPTION PERCEPTION SURVEY-2023

In the last 23 years, Transparency International Pakistan has conducted National Corruption Perception Surveys eight times: NCPS 2002, NCPS 2006, NCPS 2009, NCPS 2010, NCPS 2011, NCPS 2021, NCPS 2022 and NCPS 2023.

The NCPS 2023 comprises the perception of levels and frequency of corruption perceived by the Pakistani Citizens. ΤI Pakistan conducted National Corruption Perception Survey 2023 through its Partner Organizations, in all four provinces from 13 October 2023 to 31 October 2023 with 1,600 respondents (400 respondents from each Province).

STATE OF IMPLEMENTATION OF ONLINE PROACTIVE DISCLOSURE PROVISION

Right of Access to Information is a backbone of democracy. Pakistan has come a long way in ensuring that effective Access to Information laws are enacted at the federal and provincial level. The Second generation RTI laws are distinguished from the First generation RTI laws in number of ways including provision of Proactive Disclosure information to the citizens of Pakistan mainly through the websites of public departments.


State of Implementation of Proactive Disclosure Provision – Case Study of Federal Right of Access to Information Act 2017 is an attempt to identify gaps regarding proactive disclosure of information by the Federal Ministries and Departments of the Federal Government, in line with Section 5 of Right of Access to Information Act 2017.

Since May 2020, Transparency International Pakistan has been monitoring the implementation of Proactive Disclosure provisions in the context of federal and provincial RTI laws.

In this regard, TI Pakistan has published case studies of Sindh Transparency and Right to Information Act 2016, The Khyber Pakhtunkhwa Right to Information Act 2013 and Punjab Transparency and Right to Information Act 2013.


This study on Federal RTI Act 2017 finds that the official websites of various important ministries and the departments of the Federal Government disclose only little information. The selected ministries and departments have been studied in the context of 9 clauses of Section 5 of Federal Right of Access to Information Act 2017.

The study provides various recommendations aimed at enhancing the understanding of public bodies of their legal obligation to disclose information to the citizens and the role of the Pakistan Information Commission. It is hoped that the ministries and the federal government departments will use the findings of this research to ensure effective implementation of proactive disclosure as per the Federal Right of Access to Information Act 2017.












