Subject: Violation of AJ&K PPRA Rules 2017, Executive Engineer, PWD Buildings/ PHE

Division Neelum, Azad Jammu & Kashmir's Tender Notice for Construction and Repair/

Maintenance Works.

Dear Sir,

This is with reference to your tender notice appeared in daily 'Dawn' newspaper on 31st May, 2023. The said advertisement is in violation of AJ&K Public Procurement Rules, 2017, Rule No. 13 'Response Time'.

In the tender notice, the submission and opening dates of bids is given on 10<sup>th</sup> June, 2023, where it does not fulfill the fifteen days of response time, and is four (4) days less. It is a violation of AJ&K PPRA Rules 2017, Rule 13; quoted below for your reference:

- 13. Response time.-(1) The Procuring Agency may decide the response time for receipt of Bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the individual procurement's complexity, availability and urgency. However, under no circumstances, theresponse time shall be less than fifteen days for national competitive Bidding and thirty days for international competitive Bidding from the date of publication of advertisement or notice. All advertisements or notices shall expressly mention the response time allowed for that particular procurement along with the information for collection of Bid documents which shall be issued till a given date, allowing sufficient timeto complete and submit the Bidby the closing date: Provided that no time limit shall be applicable in case of Emergency.
- (2) The response time shall be calculated from the date of first publication of the advertisement in a newspaper or posting on the web site, as the case may be.

Chief Engineer is requested to issue directives to Executive Engineer, PWD Buildings/ PHE Division to rectify the given mistake and issue corrigendum in accordance with AJ&K PPRA Rules 2017 to avoid mis-procurement under Rule 50.

- Bidding documents are available on the Dashboard of E-registered Contractors/Firms.
- All the Bidders must have to submit the documents mention at S. # 4 above along with valid/original CDR, who do not submit signed stamped bidding documents/profile along with valid CDR, will be debarred from participating in bidding process for one year.
- The Bid Securities of unsuccessful bidders will be returned upon award of contract to the successful bidder or on the expiry of Validity of Bid, whichever is earlier.
- Electronic bidding shall be done on Percentage (above/below) basis on Market and Prevailing AJK-CSR District Neelum. Bidders have to quote only two digits after the decimal point.
