Subject: Violation of BPPRA Rules 2014 by Office of Executive Engineer, Public Health Engineering Division, Jaffarabad, Balochistan in the Procurement of Construction of Storage Tank, Providing and Installation of Filter Plant and Supply & Installation of Solar System.

Dear Sir,

The said advertisement is in violation of BPPRA Rules 2014, Rule 40 (Announcement of evaluation reports) & Rule 36 (Clarification of bids). The tender notice appeared in Express newspaper on 23rd May, 2023.

1. In the said tender notice, it is quoted that; "The tender committee reserves the right to cancel /reject any or all offers without assigning any reason."

However according to BPPRA Rule No 40; "Announcement of evaluation reports" it is clearly stated that the procuring agency shall announce the results of bid evaluation giving justification for acceptance of lowest evaluated bid, and reasons for non-acceptance of all other bids or rejection of each bid.

The BPPRA Rule No 40 is quoted below for your reference;

40. Announcement of evaluation reports.— (1) Procuring Agencies shall announce and upload on Authority's web the results of bid evaluation in the form of a report giving justification for acceptance of lowest evaluated bid, and reasons for non-acceptance of all other bids or rejection of each bid at least ten days prior to the award of procurement contract.

Provided that a copy of the evaluation report shall be provided to any bidder who may request for the same.

2. Also, in the said tender notice it is stated that; "The tender committee reserves the right to change the quantities without assigning any reason."

However according to BPPRA Rule No 36; "Clarification of bids" it clearly mentioned that the bidder shall not be allowed to alter or modify their bids after the expiry of deadline for the receipt of the bid. In case the procuring agency make alterations or changes to the bid it will impact the bidder's bid.

The BPPRA Rule No 40 is quoted below for your reference;

36. Clarification of bids.— (1) No bidder shall be allowed to alter or modify his bid(s) after the expiry of deadline for the receipt of the bids:

Chief Secretary Balochistan is requested to issue directives to the Executive Engineer, PHE Division to rectify the given mistakes and issue a corrigendum in compliance with BPPRA Rules 2014 to avoid mis-procurement.
