Subject: Violation of Balochistan Public Procurement Rules 2014, Conservator of Forest Localai's Tender Notice for Construction of Residence for Divisional Forest Officer Localai

Dear Sir,

This is with reference to your tender notice appeared in daily 'Express' newspaper on 9th May, 2024. The said advertisement is in violation of 'The Balochistan Public Procurement Rules, 2014', Rule No. 16 Response Time.

In the tender notice, the submission and opening dates of bids is given on 21 May, 2024 where it does not fulfill the fifteen days of response time, and is three (3) days less. It is a violation of Balochistan Public Procurement Rules 2014, Rule No. 16. The Rule is quoted below for your reference;

16. Response Time.— (1) Response time which shall not be less than fifteen (15) calendar days from the date of publication of Notice Inviting Tender in the newspapers or uploading on the website, as the case may be, in case of National Competitive Bidding; and shall not be less than thirty (30) days from the date of publication of Notice Inviting Tender in the newspapers or uploading on the website, in case of International Competitive Bidding:

Conservator of Forest Loralai is requested to rectify the given mistake and issue corrigendum in accordance with BPPRA Rules 2014 to avoid mis-procurement.

Article 19-A makes the right to access of information pertaining to a public authority a fundamental right, and a three member bench in case of Mukhtar Ahmad Ali vs the Registrar, Supreme Court of Pakistan, Islamabad, headed by Chief Justice Qazi Faez Isa in the landmark judgment on 16 October 2023, in CP No. 3532/2023, has declared that
