Subject: Violation of Rule No. 33(7) of KPPRA Rule 2014, Tender Notice for Procurement of Furniture, Plant and Machinery, LT Equipment and Hardware Stationery & Other Items in Tender dated 26 May 2024

Dear Sir,

This is with reference to your tender notice appeared in daily 'Mashriq' Newspaper on 26 May, 2024 the said advertisement is in violation of The KPPRA Rule 2014, Rule 33(7) 'Bid solicitation documents'.

In the said tender notice, under point No. 3, it is stated that; "Furniture, Plant and Machinery, LT Equipment and Hardware Stationery & Other Items maybe Increased or decreased or altered subject to the availability of funds and other constraints."

However according to KPPRA Rule 2014, Rule 33(7); "Bid solicitation documents" it clearly mentions that the 'In case of modification of solicitation documents by the procuring entity it shall do so by issuing an addendum or corrigendum and intimate the bidders publicly or individually. Hence, it is a violation of Rule No. 33(7) of KPPRA Rule 2014.

The Rule is quoted below for your reference;

33. Bid solicitation documents.--(7) In case of modification of solicitation documents by the procuring entity in accordance with section 23(9) of the Act, it shall do so by issuing an addendum or corrigendum and intimate the bidders publicly or individually, in case it has issued the solicitation documents, 5 days before the closing date. In case, the changes are substantial, the time for submission may be extended proportionately, by issuing timely intimation to all bidders.

Additional District & Sessions Judge-III Mansehra / Chairman Procurement Committee is requested to kindly rectify the given mistake and issue corrigendum in accordance with KPPRA Rules to avoid isprocurement under KPPRA Rules 2014 Rule 54.

This is to clarify that Transparency International Pakistan is not a complainant, it acts as a whistleblower and operate under Article 19-A, of the Constitution of Pakistan which gives the right to public to know how government is being run by public officers. Article 19-A makes the right to access of information pertaining to a public authority a fundamental right, and a three member bench in case of Mukhtar Ahmad Ali vs the Registrar, Supreme Court of Pakistan, Islamabad, headed by Chief Justice Qazi Faez Isa in the landmark judgment on 16 October 2023, in CP No. 3532/2023, has declared that

"What previously may have been on a need-to-know basis Article 19A of the Constitution has transformed it to a right-to-know, and the Access to information is no longer a discretion granted through occasional benevolence, but is now a fundamental right available with every Pakistani which right may be invoked under Article 19A of the Constitution"
