Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Principal, Cadet College Mamadgat, Khyber Pakhtunkhwa's Tender Notice for Supply of Security Equipments.

Transparency International Pakistan has received a complaint alleging of irregularities in the Tender Notice for Supply of Security Equipment by Cadet College Mamadgat Mohmand. The complaint is copied below:

1. The subject tender was published in newspaper on 05/07/2020 while tender was conducted on 15/07/2020 where only ten days of time was kept between publication and opening *dates*, which should be at least 15 days from the date of publication as per KPPRA rules, thus violating the said rules.
2. On opening date i.e 15/07/2020 of tender we four' firms attended the tender at Cadet College Mohmand along with seal envelops of Technical & Financial proposals.
3. On the date of bidding we all contractors were present at Cadet College Mamadgat on 10:30 am along with our bidding documents for tender opening but the tendering authority who published the tender was absent on the same date.
4. No Tender Box was offered to the contractors for putting our sealed envelopes to open the tender through a legal process. Upon query from the concerned clerk of the college about the director administration, who told that he is sleeping in his house and cannot attend the tender.
5. We requested the college head clerk to open the tender but he refused that he cannot open tender without permission of the director admin. Again we requested him to collect sealed envelopes from the firms and we will attend the tender on any future date as and when your administration desire, but head clerk was not willing to collect our bidding documents and refused to do so. We also request him to issue tender cancellation notice .The clerk told that he contacted the concerned authority who is not allowing to open the tender nor giving cancellation notice or future date. All contractors were waiting for tender opening till 2:00 pm but all options were denied and tender remained unopened and concealed. We got signed attendance sheet from the head clerk as a proof of attending the same tender. Further, we have all relevant documents seal packets of bidding as proof of attending the same tender

Transparency International Pakistan requests the Principal Cadet College Mamadgat to examine the complaint and if found correct address the irregularities of the tendered processes. The irregularities pointed are prima facie in violation of the KPPRA Rules 2014.



Furthermore, KPPRA Rules 2014, Rule No.34 (1). Stated as under:

34. Response time. - (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the individual procurement's complexity, availability and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Transparency International Pakistan is striving for across the board application of Rule of Law, which is the only way to stop corruption.

Subject: **Enquiry of Misappropriation of Tender at Cadet College Mamadgat Mohmand**

Respected Sir,

We would like to draw your attention to the tender no.PID (P) 162/2020 published for supply of security equipments (copy attached) by Cadet College Mamadghat Mohmand in Daily Aaj newspaper dated 05/07/2020. Following irregularities were conducted as per KPPRA/PPRA rules by the college administration who published the tender.

1. The subject tender was published in newspaper on 05/07/2020 while tender was conducted on 15/07/2020 where only ten days of time was kept between publication and opening dates, which should be at least 15 days from the date of publication as per KPPRA rules, thus violating the said rules.
2. On opening date i.e 15/07/2020 of tender we four firms attended the tender at Cadet College Mamad along with seal envelops of Technical & Financial proposals.
3. On the date of bidding we all contractors were present at Cadet College Mamadgat on 10:30 am along with our bidding documents for tender opening but the tendering authority who published the tender was absent on the same date.
4. No Tender Box was offered to the contractors for putting our sealed envelopes to open the tender through a legal process. Upon query from the concerned clerk of the college about the director administration, who told that he is sleeping in his house and cannot attend the tender.

All contractors were waiting for tender opening till 2:00 pm but all options were denied and tender remained unopened and concealed. We got signed attendance sheet from the head clerk as a proof of attending the same tender. Further, we have all relevant documents seal packets of bidding as proof of attending the same tender.

It seems that the subject tender has been allotted to some favorite contractor by the college administration, which is clear violation of KPPRA/PPRA rules, attracting corruption & damaging the image of college.

We request to kindly initiate enquiry in respect of the aforesaid tender & give us the right to attend the tender.
