Appeal filed without attorney how was supervision filed without attorney?

How the overdue appeal was filed and then how was the monitoring of this overdue appeal filed?

We filed an application for partition account of our property which was kept pending for a year during which Muhammad Masood was sued for false oral.

Due to the oral sale case, the partition process was pending by the Tehsildar..

A few months later, Khalid Muhammad et al lost the case in the civil court because they could not prove it, after which the process of partition was started again.

This process was challenged by Khalid Mehmood to Deputy Commissioner Rahim Yar Khan, who was also dismissed from there. After that, Khalid Mahmood filed an appeal to Additional Sessions Judge Liaquatpur against the false claim, which was again justified and the distribution process was stopped.

After that, Farhat Parveen requested the **FEMAL OMBUDSMAN of Punjab, Lahore**, that my separate Wanda (distribution) should be prepared. Khalid Mahmood was called at the female ombudsman of the court. Where Khalid Mehmood gave a statement not to interfere in Wanda, after Khalid Mehmood's statement, the female ombudsman of Punjab ordered Deputy Commissioner Rahim Yar Khan to complete the process of distribution of quickly and hand over the occupied land to Farhat Parveen, but this order was rejected by the tehsil staff.

Then a reminder was sent again, but the mafia sitting in the tehsil did not even care about it, after which the female ombudsman of Punjab sent a notice of contempt of court to Deputy Commissioner Rahim Yar Khan and it was also printed in the newspapers of Lahore.

Even after that, the distribution process was not completed and only ten (kanals) of land was given to Farhat Parveen. This division was challenged and the decision was in our favor that the land should be given in full.

The process of partition was repeated in which Khalid Mahmood did not intervene. Because the Tehsil staff was not getting anything, they have been delaying since the first day and giving full guidance to Khalid Mahmood.

Due to the delay tactics and deal, Khalid Mahmood filed an appeal on his behalf with the Additional Deputy Commissioner in the case of Mah Jabeen without power of authority and Iftikhar Ahmed without authority in account 65/56 Mouz Gabra and account number 259 Mouza Ashraf shah which was dismissed. The female provincial ombudsman also wrote a letter asking for possession, but the Tehsil staff did not even bother to give the answer to the female ombudsman.

After delaying tactics, Khalid Mahmood went under surveillance. The vigilance has also been discharged while the female provincial ombudsman has written several letters to Deputy Commissioner Rahim Yar Khan for the past four months, but no response has been given. While Khalid Mahmood is being provided full guide and facilitation by Reader Assistant Commissioner and Tehsildar staff. Deputy Commissioner maybe it is out of control or maybe tehsil staff is out of control the deputy commissioner rahhimyar khan the system is not supporting them all.

Who doesn't want to fix the system?

Can Pakistan go further in this way?

Will the incompetent bureaucracy be able to give the people their property rights and human rights?

Will the incompetent bureaucracy continue to promote occupations by giving unnecessary stays order?

Will this system continue to operate like this?

Is the technical corrupt bureaucrat sitting in our institutions an obstacle to fixing the system?

Does the Army want an end to corruption and technical corruption from Pakistan?

Are such technical stay orders granted to promoted land mafia,s occupation in Pakistan? There is no accountable here in Pakistan.

I gave the request dated 14.02.24 to the senior member for urgent hearing and transfer case as the member board was not coming to Bahawalpur this request is still pending with the senior member without any reason.

Pray:

Who will take possession of the land, the army chief or no one else because the system is promoting the occupations?

Our lives are not safe, our properties are not safe from the judiciary, our businesses are not safe, our institutions are providing protection to crimes in which the judiciary is at the top.

Because the occupier keeps paying bribes, the system stands with him.

If the owner gets possession of the land (chicken), then the chicken died, then the judiciary, revenue staff will eat the eggs from where?

I am waiting about your response.

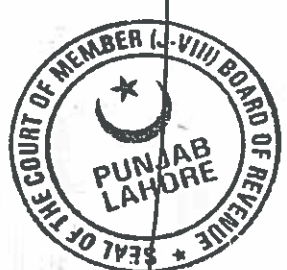
