Subject: Violation of Punjab Procurement Rules 2014, Administrator, District Council, Gujranwala's Tender Notice for Repair & Rehabilitation Work.

Dear Sir.

The said advertisement is in violation of Punjab Procurement Regulatory Authority Rules 2014, Rule 14 'Response Time'. The tender notice appeared in daily 'Express' on 2nd July, 2023.

In the said tender notice, 15 days of response time is not given as the submission/ opening of bids is on 12.07.23, which is four (4) days less and does not fulfill the fifteen days of response time as per The Punjab Procurement Rules 2014. Hence, it is a violation of 'The Punjab Procurement Rules 2014, Rule No. 14 (1); quoted below for your reference;

14. Response time.— (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for prequalification) from the date of publication of an advertisement or notice keeping in view the complexity of the procurement, availability and urgency but, in no circumstances, the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice

Administrator, District Council is requested to rectify the given mistake and issue corrigendum in accordance with Punjab Procurement Rules 2014 to avoid mis-procurement under Rule 69.
