Subject: Violation of Punjab Procurement Rules 2014, Executive Engineer, Buildings Division, Mianwali, Superintending Engineer, Buildings Circle, Sargodha, Punjab Buildings Department, Lahore's Tender Notice for Correctional Facilities and Reconstruction Works.

Dear Sir.

This is with reference to your tender notice appeared in daily 'Dawn' newspaper on 5<sup>th</sup> December, 2023. The said advertisement is in violation of Punjab Procurement Rules 2014, Rule 25(7) 'Bidding documents'.

In the tender notice the fee for purchasing bidding document for work under S.r.No1 is given as Rs 20,000/-, which is a high amount. However as per Punjab Procurement Rules 2014, Rule No. 25(7), procuring agency shall provide a set of bidding documents to any supplier or contractor, on request and subject to payment of price, which means the cost of printing only. Hence, it is a violation Punjab Procurement Rules 2014, Rule No 25(7).

The Rule is quoted below for your reference;

25. Bidding documents.— (7) The procuring agency shall, on payment of such fee as the procuring agency may determine keeping in view the cost of printing and provision of the documents, provide a set of bidding documents to the prospective bidders.

Chief Engineer, Punjab Buildings Department is requested to issue directives to Executive Engineer, Buildings Division, Mianwali and Superintending Engineer, Buildings Circle, Sargodha to rectify the violation and issue corrigendum in accordance with Punjab Procurement Rules 2014 to avoid misprocurement under Rule 69.

## Note:

This is to clarify that Transparency International Pakistan is not a complainant, it acts as a whistleblower and operate under Article 19-A, of the Constitution of Pakistan which gives the right to public to know how government is being run by public officers. Article 19-A makes the right to access of information pertaining to a public authority a fundamental right, and a three member bench in case of Mukhtar Ahmad Ali vs the Registrar, Supreme Court of Pakistan, Islamabad, headed by Chief Justice Qazi Faez Isa in the landmark judgment on 16 October 2023, in CP No. 3532/2023, has declared that

"What previously may have been on a need-to-know basis Article 19A of the Constitution has transformed it to a right-to-know, and the Access to information is no longer a discretion granted through occasional benevolence, but is now a fundamental right available with every Pakistani which right may be invoked under Article 19A of the Constitution"
