Subject: Violation of Punjab Procurement Rules 2014, Chairman Jhang Educational Trust/
Deputy Commissioner Office, Chenab College Athara Hazari, Jhang's Tender Notice for
Construction Works.

Dear Sir.

This is with reference to your tender notice appeared in daily 'Express' newspaper on 29<sup>th</sup> January, 2024. The said advertisement is in violation of Punjab Procurement Rules 2014.

1. In the said tender notice, 15 days of response time is not given as the submission/ opening of bids is on 09-02-2024, which is three (3) days less and does not fulfill the fifteen days of response time as per Punjab Procurement Rules 2014. Hence, it is a violation of Rule No. 14 of Punjab Procurement Rules 2014.

The Rule is quoted below for your reference;

- 14. Response time.— (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for prequalification) from the date of publication of an advertisement or notice keeping in view the complexity of the procurement, availability and urgency but, in no circumstances, the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.
- 2. Also, in the notice, it is stated under p.no. 6, that; "Deputy Commissioner Jhang/ Chairman JET reserves the right to accept any or cancel/reject all offers without assigning any reason thereof."

As per the Punjab Procurement Rules 2014, Rule 35 the procuring agency shall upon request communicate to any bidder who submitted a bid or proposal, the grounds for its rejection although it is not required to justify those grounds. Hence, it is a violation of Rule No. 35.

The Rule is quoted below for your reference;

- 35. Rejection of bids.— (1) The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal.
- (2) The procuring agency shall upon request communicate to any bidder, the grounds for its rejection of all bids or proposals, but shall not be required to justify those grounds.
- (4) The bidders shall be promptly informed about the rejection of the bids, if any.

Deputy Commissioner Jhang/ Chairman JET, is requested to rectify the violation and issue corrigendum in accordance with Punjab Procurement Rules 2014 to avoid mis-procurement under Rule 69.

This is to clarify that Transparency International Pakistan is not a complainant, it acts as a whistleblower and operate under Article 19-A, of the Constitution of Pakistan which gives the right to public to know how government is being run by public officers. Article 19-A makes the right to access of information pertaining to a public authority a fundamental right, and a three member bench in case of Mukhtar Ahmad Ali vs the Registrar, Supreme Court of Pakistan, Islamabad, headed by Chief Justice Qazi Faez Isa in the landmark judgment on 16 October 2023, in CP No. 3532/2023, has declared that

"What previously may have been on a need-to-know basis Article 19A of the Constitution has transformed it to a right-to-know, and the Access to information is no longer a discretion granted through occasional benevolence, but is now a fundamental right available with every Pakistani which right may be invoked under Article 19A of the Constitution"
