Subject: Violation of PPRA Rules 2004, Executive Engineer, Public Health Engineering Division, Shiekhupura's Tender Notice for Construction of Underpass.

Dear Sir,

This is with reference to tender notices appeared in daily 'Dawn said advertisements are in violation of Punjab Procurement Rules 2014, Rule 25(7) 'Bidding documents'.

In the tender notice the fee for purchasing bidding document is Rs 20,000/-, which is relatively a high amount. However as per Punjab Procurement Rules 2014, Rule No. 25(7), procuring agency shall provide a set of bidding documents to any supplier or contractor, on request and subject to payment of price, which means the cost of printing only. Hence, it is a violation Punjab Procurement Rules 2014, Rule No 25(7).

The Rule is quoted below for your reference;

25. Bidding documents.— (7) The procuring agency shall, on payment of such fee as the procuring agency may determine keeping in view the cost of printing and provision of the documents, provide a set of bidding documents to the prospective bidders.

Secretary HUD&PHED is requested to issue directives to Executive Engineer PHE Department, Sheikhupura to rectify the violation and issue corrigendum in accordance with Punjab Procurement Rules 2014 to avoid mis-procurement under Rule 69.

The lowest bidder will hap to deposit an additional performance security from the scheduled Bank equal to the tender amount below estimated cost within 15 days of issuance of notice.

 As per PPRA Rule 2014, Serial No.56 Chapter-VIII, successful bidder has to furnish Performance Guarantee from any scheduled bank @5% (minimum) of the bid amount for the work mentioned above.
