Subject: Violation of Punjab Procurement Rules 2014, Chief Officer, Deputy Commissioner/
Administrator, District Council, Bahawalpur's Tender Notice for Procurement of
Machinery.

Dear Sir,

This is with reference to your tender notice appeared in daily 'Express' newspaper on 30th December, 2023. The said advertisement is in violation of Punjab Procurement Rules 2014, Rule 33(1) 'Clarification of Bids'.

In the said tender notice, under p.no. 8, it is stated that; "The Procuring agency has the right to increase or decrease the quantity of any items before and after issuance of supply order."

However according to Punjab Procurement Rules 2014, No 33(1); "Clarification of bids" it clearly mentioned that the bidder shall not be allowed to alter or modify his bid after the submission of bids. In case the procuring agency makes alterations or changes to the bid it will impact the bidder's bid. Hence it is a violation of Punjab Procurement Rules 2014, No 33(1). Quoted below for your reference;

- 33. Clarification of bids.— (1) No bidder shall be allowed to alter or modify his bid after the closing time for the submission of the bids.
- (2) The procuring agency may, if necessary after the opening of the bids, seek and accept such clarifications of the bid as do not change the substance of the bid.
- (3) Any request for clarification in the bid, made by the procuring agency and its response, shall invariably be in writing.

Chief Officer, Deputy Commissioner/ Administrator, District Council, Bahawalpur is requested to rectify the violation and issue corrigendum in accordance with Punjab Procurement Rules 2014 to avoid mis-procurement under Rule 69.

This is to clarify that Transparency International Pakistan is not a complainant, it acts as a whistleblower and operate under Article 19-A, of the Constitution of Pakistan which gives the right to public to know how government is being run by public officers. Article 19-A makes the right to access of information pertaining to a public authority a fundamental right, and a three member bench in case of Mukhtar Ahmad Ali vs the Registrar, Supreme Court of Pakistan, Islamabad, headed by Chief Justice Qazi Faez Isa in the landmark judgment on 16 October 2023, in CP No. 3532/2023, has declared that

"What previously may have been on a need-to-know basis Article 19A of the Constitution has transformed it to a right-to-know, and the Access to information is no longer a discretion granted through occasional benevolence, but is now a fundamental right available with every Pakistani which right may be invoked under Article 19A of the Constitution"

 5- Technical Bids shall be opened on the same date after 30-minutes of closing time, in the

- 6- Financial proposals of only those (technically qualified) venders / firms shall be opened after evaluation of technical proposal by the committee concerned, and the firms / venders will be informed accordingly

 7- According to PPRA rule-35, the procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicale to any bidder, the grounds for its rejection of all bids or proposals, but shall not be required to justify those grounds.
- 8- The Procuring Agency has the right to increase or decrease the quantity of any items before and after issuance of supply order. The decision of the Procuring Agency will be final and not be challenged in any Court of law.
- 9- Detail terms & conditions will be mentioned in bidding documents.
- 10- Rates offered by the Firm / Vender will be applicable for the whole financial year 2023-24.
