Subject: Complaint against LDA for delayed completion of exemption process for possession of two Plots of 1 Kanal 14 Marla each in Khasra No. 2667/2642 in Mohlanwal Lahore since 1982

Dear Sir,

TI Pakistan has received a complaint from Dr. Azeem Ahmed Iqbal S/o Dr. Iftikhar Iqbal, against LDA for delaying the possession and completion of exemption process of two plots of 1 Kanal 14 Marla each in Khasra No. 2667/2642 in Mohlanwal Lahore purchased by his father in 1982.

The complainant has raised the following serious allegations.

That.

- Dr. Iftikhar Iqbal purchased two plots of 1Kanal 14 Marla each in Khasra No 2667/2642 in Mohlanwal Lahore in name of my daughter or Dr Javaria Iqbal and my son Nadeem Ahmed Iqbal in 1982 which was later acquired by LDA for LDA, Mohlanwal Society, Lahore.
- Since 1982, the complainant has submitted various applications in the last 38 years to get the
 exemption against acquired land. Complainant has furnished all the requisite documents
 many times in the directorate, however, LDA has not completed the exemption process.
- 3. The working papers of these files are ready from last many months and all reports are complete in directorate (DLD-3). It is requested that ADG (HOUSING) may kindly be asked to expedite the exemption process of these files (File No. 164 & 165 owned by Dr. Javaria Igbal and Nadeem Ahmed Igbal).
- 4. I am a heart patient and more than 70 years old and have spent more than half of my life trying to get my right from LDA. It is requested that these files may kindly be requisitioned for next exemption committee meeting for completion of exemption process so that we can get exemption at the earliest.

Transparency International Pakistan has examined the complaint based on the documents provided by the complainant, and prima facie it appears that the allegations are correct. DG LDA is requested to examine the complaint and if the department also finds the complaint to be correct, LDA may expedite the process so that the complainant and his family are provided redress for the problems.
