Learned counsel for the petitioner relies upon the order dated 17.08.2021 passed in WP No. 46179 of 2021, whereby the matter was referred to Public Procurement Regulatory Authority ("PPRA") to determine whether the Respondent PMC for the purpose of holding examination was receiving funds that could be treated as public funds; secondly whether the Respondent PMC was bound to grant contract through procedure provided under PPRA Rules, 2004 for the purpose of outsourcing/ holding said examination. Adds that vide order dated 18.10.2021, PPRA has ruled that as the funds were in the nature of public fund, therefore, procurement through proper prescribed procedure was necessary. The Petitioner challenges the contract awarded to Respondent Nos. 8 and 9 by Respondent PMC and states that as the Petitioner was one of the applicants in the said process, therefore, he had locus standi to challenge the contract awarded to respondents without following the procedure which was not justified.

2. Let notice be issued to the Respondents with a direction to respondent Nos. 3 to 7 to file report and parawise comments for 29.11.2021. Learned counsel



appearing on behalf of Respondent No. 3/PMC accepts notice and seeks time to file comments.
