Transparency International Pakistan would like to bring to your attention the lack of information regarding a designated Public Information Officer (PIO) in accordance with the Punjab Transparency and Right to Information Act 2013 on the department's website: <https://pdma.gop.pk/> accessed on March 21, 2024.

Section 4 clause 'I' - Proactive Disclosure, Punjab Transparency and RTI Act 2013 is quoted below for your reference,


"name, designation and other particulars of the public information officer of the public body; and"

TI Pakistan acknowledges the fact that Access to Information laws are an important step towards transparency and social accountability. TI Pakistan has been striving for the enactment and implementation of RTI laws in Pakistan since 2002 so that the citizens are able to exercise their right to information.

Transparency International Pakistan requests the Director General PDMA to issue directives for the compliance with Section 4 (I) Punjab Transparency & RTI Act 2013 and uploading the mandatory information including the particulars of public information officer (PIO) on the department's website.

Note:

This is to clarify that Transparency International Pakistan is not a complainant, it acts as a whistleblower and operate under Article 19-A, of the Constitution of Pakistan which gives the right to public to know how government is being run by public officers. Article 19-A makes the right to access of information pertaining to a public authority a fundamental right, and a three member bench in case of Mukhtar Ahmad Ali vs the Registrar, Supreme Court of Pakistan, Islamabad, headed by Chief Justice Qazi Faez Isa in the landmark judgment on 16 October 2023, in CP No. 3532/2023, has declared that

“What previously may have been on a need-to-know basis Article 19A of the Constitution has transformed it to a right-to-know, and the Access to information is no longer a discretion granted through occasional benevolence, but is now a fundamental right available with every Pakistani which right may be invoked under Article 19A of the Constitution”
