Subject: Complaint on summary sent on 21<sup>st</sup> February 2023 to former Sindh Chief

Minister Syed Murad Ali Shah by the provincial health department (seven months back)

for the appointment of a new Executive Director to the National Institute of

Cardiovascular Diseases (NICVD), was never tabled before him for approval by the CM

House staff, and even to the caretaker Chief Minister

Dear Sir,

Transparency International Pakistan has received another complaint on the summary sent on 21<sup>st</sup> February 2023 to former Sindh Chief Minister Syed Murad Ali Shah by the provincial health department seven months back for the appointment of a new Executive Director to the National Institute of Cardiovascular Diseases (NICVD), was never tabled before him for approval by the CM House staff, and even to the Caretaker Chief Minister.

The complainant has made the following allegations:

#### That;

On 4th January 2023, the Sindh High Court, hearing the NICVD corruption case C.P No. D-3463 of 2019 & C.P No. D-5143 of 2020, reprimanded the health secretary and said that he had destroyed the health system of the province, and also rebuked NICVD Executive Director Nadeem Qamar for occupying a government position after his retirement.

The judges also remarked on how Dr. Nadeem Qamar had come back to hold an official position after his retirement. "You should have surrendered the position by yourself. A member of the NICVD Governing Board requested the court to give three months to decide the policy. The court questioned why the government wanted to make a policy decision when the NICVD Act existed and asked, how will you fix it in three months.

The Court said "You talk about the supremacy of the law? then establish the rule of law in everything," Justice Panhwar said. Addressing Health Secretary Kazim Jatoi, the court said that he had destroyed the health system of the province.



- 2. However, on 30<sup>th</sup> August 2022, Govt. of Sindh constituted a selection committee for appointment of Executive Director, NICVD, Karachi vide Services General Administration & Coordination Department (SGA&CD) (Annex-A).
  - Mr. Hasan Naqvi, Chairman Planning & Development Board, was appointed as Chairman of the Committee, and other 4 members included Mr. Kazim Jatoi, Secretary Health, and Secretary (services) SAG&D.
- 3. The maximum age for contract appointment as per Government Rules is 65 years, and for 4 year contract, applicant shall be less than 61 years (Annex-B). However, the scrutiny committee constituted to scrutinize documents and shortlist candidates in light of the terms and conditions set in the advertisement for the post of ED, NICVD illegally declared Dr. Nadeem Qamar within maximum age despite him being over age (Annex-C).
- 4. On 21<sup>st</sup> February 2023, the Selection Committee sent the summary to the Chief Minister Sindh and proposed that Prof. Tahir Saghir may be appointed as the Executive Director, NICVD, Karachi for a period of four years on the prescribed terms and conditions of the NICVD Act. (Annex-D).
- 5. The summary sent to former Sindh Chief Minister Syed Murad Ali Shah by the provincial health department for the appointment of a new executive director to the National Institute of Cardiovascular Diseases (NICVD) on 21.2.2023 was never tabled before him by the previous Principal Secretary for approval by the CM deliberately.
- 6. The present Principal Secretary to CM, Mr. Hasan Naqvi, who was also the Chairman of the Selection Committee has also not tabled the Summary for approval of Caretaker CM since one month.
- 7. The Caretaker Health Minister Dr. Saad Khalid Niaz has also said he would discuss it with the Caretaker CM.

In Rules, in any of the PSE in Federal Government and Provincial Government, no officer above 65 years age can be appointed. On 7 November 2018, Supreme Court declared appointment of Atta-ul-Haq Qasmi as Managing Director and Chairman of Pakistan Television as illegal and without any lawful effect, one reason being over age limit of 65 years, and that Rs197m shall be recovered from ex-PTV Chairman, former ministers & others.

Similarly on 16 January 2021, the Federal Cabinet removed Mr. Naeem Bukhari as Chairman Pakistan Television (PTV) as he was above 65 years and in light of the Islamabad High Court (IHC) order in a petition challenging the PTI leader's appointment. The IHC had earlier restrained Naeem Bukhari from working as Chairman of the PTV. A single bench led by IHC Chief Justice Athar Minallah had announced the decision while hearing a set of petitions challenging Bukhari's appointment citing it a violation of 2018 Supreme Court order in a similar case.

8. Dr. Nadeem Qamar is known to be drawing over Rs 6 million as monthly emoluments, and since last 17 months, approx. over Rs 100 million irregularly are paid by NICVD, needs to be recovered from him and others, as was decided by Supreme Court in 2018 in MD PTV case.



9. NICVD has also consistently violated SPPRA Rules 2010. As per SPPRA Rules 2010, Rule no. 11, detailed Procurement Plan of all contracts to be awarded in the fiscal year 2023-24, are to be posted on SPPRA website, indicating against each the method of procurement, scheduled month of procurement, and amount of procurement (Annex-E). However, NICVD ED Dr. Nadeem Qamar has failed to abide by SPPRA Rules and Rs 16 billion budget did not provide the individual project/procurement, in violation of SPPRA Rule No 11 and Rule No. 12, which prohibits splitting or combining contracts as mentioned in the declared Procurement Plan (Annex-F)

## TI Pakistan's Comments

Transparency International Pakistan has reviewed the allegations of the complaint, prima facie, the allegations seem to be correct.

Following are TI Pakistan comments:

- 1. On 24<sup>th</sup> August, 2023, TI Pakistan has written to the office of the Caretaker Chief Minister, Sindh on the Complaint on the Violation of Orders Passed by the Honorable High Court of Sindh through Deliberate Delay in the Appointment of Executive Director of NICVD and Non-approval of the Summary moved by the Selection Committee Constituted under Chairman Planning & Development Board, Govt of Sindh, Pending with the Chief Minister Office for last over 6 months, since 21st February 2023 (Annex-G).
- 2. The delay in approval of the Selection Committee recommendations is not only a violation of SHC Orders of January 2023 in NICVD corruption case C.P No. D-3463 of 2019 & C.P No. D-5143 of 2020, but is also against the Rule of Law. It also raises concerns of deliberate delay as PSCM was himself Chairman of the selection Committee, to continue the services of ED on acting basis when the selection committee has proposed final name for the appointment as ED of NICVD.
- 3. Any violation of SPPRA Rules 2010 amounts to Mis-Procurement under Rule No 33 A.

### TI Pakistan's Recommendations

Transparency International Pakistan requests the caretaker Chief minister Sindh to look into the allegations including attempts to make wrong statement on the age of Dr. Nadeem Qamar, and if found correct, to take decision on the summary pending since February 2023 on the appointment of the Executive Director NICVD, in light of the summary of the Selection Committee Constituted by the Govt. of Sindh on the appointment of Executive Director NICVD, and take action against those responsible for illegally declaring candidate within maximum age.

Transparency International Pakistan is striving for across the board application of Rule of Law, which is the only way to stop corruption, and achieve against Zero tolerance against corruption.

- 2. Subsequently, the Health Department, Government of Sindh published the advertisement, duly vetted by the Selection Committee, to invite applications from aspirant candidates. In response, seven (07) candidates applied for appointment on the said post and out of which three (03) were shortlisted for interview.
- 3. Accordingly, a meeting of Selection Committee under the Chairmanship of Chairman Planning & Development Board, Govt. of Sindh conducted interviews of the shortlisted candidates, which was held on 02.02.2023. The Selection Committee interviewed the shortlisted candidates and their cumulative score is as follows (Annexure-III):

Subject: Complaint on the Violation of Orders Passed by the Honorable High Court of Sindh through Deliberate Delay in the Appointment of Executive Director of NICVD and Non-approval of the Summary moved by the Selection Committee Constituted under Chairman Planning & Development Board, Govt of Sindh, Pending with the Chief Minister Office for last over 6 months, since 21st February 2023.

Dear Sir,

Transparency International Pakistan has received a complaint on the allegations of violation of Orders Passed by the Honorable High Court of Sindh through deliberate delay in the Appointment of Executive Director of NICVD and Non-approval of the Summary moved by the Selection Committee Constituted under Chairman Planning & Development Board, Govt of Sindh, pending with the Chief Minister Office for last over 6 months since 21<sup>st</sup> February 2023.

The complainant has made the following allegations:

#### That;

- 1. The Honorable High Court of Sindh, Karachi had directed the Competent Authority to appoint the administrators and managers of Sindh Institute of Cardiovascular Diseases (SICVD), Karachi and National Institute of Cardiovascular Diseases (NICVD), Karachi.
- On 30<sup>th</sup> August 2022, Govt. of Sindh constituted a selection committee for appointment of Executive Director, NICVD, Karachi vide Services General Administration & Coordination Department (SGA&CD).
- 3. Subsequently, the Health Department, Government of Sindh published the advertisement, duly vetted by the Selection Committee, to invite applications from aspirant candidates. In response, seven (7) candidates applied for appointment on the post of the Executive Director, out of which three (03) were shortlisted for interview.
- 4. On 2<sup>nd</sup> February 2023, the Selection Committee under the Chairmanship of Chairman Planning & Development Board, Govt. of Sindh conducted interviews of the shortlisted candidates, and prepared the report on cumulative score as follow:

- 5. On 21<sup>st</sup> February 2023, the Selection Committee sent the summary to the Chief Minister Sindh and proposed that Prof. Tahir Saghir may be appointed as the Executive Director, NICVD, Karachi for a period of four years on the prescribed terms and conditions of the NICVD Act.
- 6. However, the Chief Minister Sindh has failed to take decision for seven months on the pending summary sent by the selection committee for the appointment of the Executive Director, NICVD to pave the way for the continuation of the service of Dr. Nadeem Qamar illegally.
- 7. The caretaker CM Sindh Justice R Maqbool Baqar on 19<sup>th</sup> August said that <u>Rule of Law</u>, conviction, and commitment were prerequisites for the improvement of the governance and the government system. How it would be achieved is the question to which he replied 'by following the constitution.'

### **Transparency International Pakistan's Comments:**

Transparency International Pakistan has reviewed the allegations of the complaint, prima facie, the allegations seem to be correct.

#### Following are TI Pakistan comments:

- 1. On 13<sup>th</sup> September 2022, TI Pakistan has written to the Principal Secretary Prime Minister vide letter No. TL22/0913/1A on the complaint on the allegation of violation of Supreme Court of Pakistan order in the biased advertisement for the post of Executive Director, National Institute Cardiovascular Diseases (NICVD) and recommended to order cancelation of the advertisement and restart of the process of appointment of ED NICVD and that the selection criteria in the advertisement is drafted to benefit Dr. Nadeem Qamar such as age limit of 65 years as maximum for application, whereas in all Government Department of Sindh and Federal Government maximum age of such potions is 65 years, and Dr Nadeem is already 64 years old. Also no salary /allowances are declared in the Advertisement for the post, which he was paid over Rs 66 lakhs/month (Annex-A).
- 2. On 31<sup>st</sup> October 2022, vide No. TL22/1031/1A TI Pakistan has written another letter to the Minister Health, Govt. of Sindh on the complaint against the Irregularities in the Appointments/Promotions of Officers in NICVD Hospital identified by Director General Audit, causing a loss of approx. Rs.69 million for the year 2020-21 (Rs 345 million in 5 years) to National Exchequer and allegation of misappropriation of Rs. 927.049 million of Doubtful transfer of funds from bank account (Annex-B)
- 3. The affairs of the NICVD are being run on acting charge basis since last 15 months since 10<sup>th</sup> May 2022, despite the directions of the selection committee on the appointment of a regular full time Executive Director, which against the principle of Rule of Law.



4. The delay in approving Selection Committee recommendations is not only the violation of SHC Orders of March 2023, but is also against the Rule of Law, to continue the services of ED on acting basis when the selection committee has proposed final name for the appointment as ED of NICVD.

#### TI Pakistan's Recommendations

Transparency International Pakistan requests the Caretake Chief Minister Sindh to look into the allegations, and if found correct, to take decision on the pending of February 2023 summary on the appointment of the Executive Director NICVD in light of the summary of the Section Committee Constituted by the Govt. of Sindh on the appointment of Executive Director NICVD.

Transparency International Pakistan is striving for across the board application of Rule of Law, which is the only way to stop corruption, and achieve against Zero tolerance against corruption.
