Transparency International Pakistan (TIP) vide there letter dated 20<sup>th</sup> May 2016, sent a complaint to Secretary to the Prime Minister, Chief Justice Sindh, Chief Secretary, Sindh, Commissioner Karachi and also Administrator KM, on immediate restoration of Park Amenity Plot ST 13 of 4840 syds area in KDA Scheme Kehkashan, Clifton Block -5, illegally encroached.. Copy of the letter is enclosed **Annex-A**.

Unfortunately no action was taken though illegal occupant of park are Karachi Police, an illegal Mosque and offices by different organizations,

Recently two buildings have been demolished in Karachi, one on one acre plot in Nehr-e-Khayyam under Supreme Court Order in SMC 16 of 2011, in 2018, and the other one at Rashid Minhas Road on 2 Acre Horticulture Plot under SMC 2016 of 2011 of Feb 2020.

In Supreme Court in HRMA NO. 65 of 2020 in HRC No 69162-P/2018, dated 19 August 2020, Justice Gulzar Ahmed, Chief Justice has ordered Member Colonies "that no land which is meant for amenity purposes i.e. for the use of residents of the City, should be allowed to be used for any other purpose, and remain open for the amusement and enjoyment." Annex-B

Transparency International Pakistan (TIP) request the Administrator to take immediate action to comply the Supreme Court orders, and get the one acres Park on Main Clifton Road vacated, and establish beautiful park.

This is also to inform the Administrator that land grabbers are manipulating to get the park for multistory building.

## That

- 1. Since 1966, KDA under its Master Plan has provided only one Park ST 12 of A acres area on main Clifton Road, starting from Round About of 2 Talwar to Round about 3 Talwar, in Block 5. Annex-A.
- 2. A Park for general public was developed by KDA which was open to every one till year 2000.
- 3. But an unauthorized mini Police Station and Mosque were built by Sindh Police on a Park which is blatant violation of law by the law and the enforcement agency KBCA/SBCA and Govt Aquaf Ministry also did not took action against the encroachment by Sindh Police and illegal mosque on an encroached public park.
- 4. Since last many years, the remaining area of Park ST 12, is being used by Defence-Clifton Residents Committee (DCRC), which has converted garden into a so called club. With name of DCRA Family Park. Annex-B.
- 5. This Park is being used by a political party for its sectors meetings and protests. Annex-C.

The complaint has been examined of mis-use of Public Park by Police and DCRC by TI PAkisdtan. And many Orders of Supreme Court are available of not allowing change of use of public reserved area for Utilities, Parks, Playgrounds, Roads, Car Parks, and all reserved amenity plots into any political or Commercial use, e.g. Judgment announced on 10.2.2015 in



## KARACHI:

A large number of people turned up at Teen Talwar on Saturday afternoon to demand the Pakistan Tehreek-e-Insaf (PTI) take back its statement against establishing administrative units in Sindh.

The Muttahida Qaumi Movement (MQM) has claimed that the statement of PTI Sindh chapter president Nadir Leghari deeply hurt the people of urban Sindh as the PTI supports independent administrative units in other parts of the country but has excluded Sindh.

"If PTI throws a brick at us, we will throw two bricks in return," said Shagufta, a visibly charged participant at Teen Talwar. She held a yellow banner that claimed that PTI was 'anti-Karachi'.

The protest was organised by the Defence-Clifton Residents Committee (DCRC) and the Council of Professionals. Though the protest was not organised by the MQM, it was led by its leader Khushbakht Shujaat and attended by a large number of its activists.

Member (Colonies), Board of Revenue states that the land will be put to use for which it was meant for originally. We caution the Member (Colonies) that no land, which is meant for amenity purposes i.e. for the use of the residents of the City, should be allowed to be used for any other purpose and remain open for their amusement and enjoyment.

2. Commissioner, Faisalabad has submitted a report stating therein that one Jehanzeb Petroleum/CNG Station, which was functioning on a greenbelt, has been dismantled and removed from the site and greenbelt is being restored. Commissioner Faisalabad is directed to ensure that all amenity areas and greenbelts as provided in the master plan of Faisalabad are restored to their original use and all non-approved activities be

discontinued immediately.
