The participants were informed that the "Review Committee" constituted under Rule-32(2) of SPP Rules-2010 is for the appeals received from the bidder(s) on all those procurements which come under the domain of SPPRA, whereas, the instant procurement has been carried out under the World Bank Guidelines where neither the SPP Rules nor its Redressal Grievance mechanism would apply.

Attention of the participants was further drawn towards Rule-5 of SPP Rules, 2010 which stipulates that "In the event that these rules are inconsistent with, or in conflict with, any obligation or commitment of Government arising out of an international treaty or an agreement with a foreign country or countries, or any international financial institution, the provisions of such international treaty or agreement shall override the provisions of these rules to the extent of that inconsistency or conflict as the case may be" therefore; the instant procurement does not come under the ambit of SPPRA, however, in order to comply the orders of honourable High Court of Sindh, this meeting has been convened.
