## Sub: <u>Publication of the Contract Agreements on SPPRA Website under Sindh Public Procurement</u> Rules, 2010, Rule 10

Dear Sir,

Transparency International Pakistan monitors implementation of SPPRA Rule 10 (quoted below) which requires all procuring agencies to upload contract award agreements along with rates/prices quoted/BOQ on the SPPRA website.

10. Transparency. - The procuring agency shall, immediately upon award of Contract, make the evaluation report of the bid, and the contract agreement public through hoisting on the Authority's website as well as on procuring agency's website, if the procuring agency has such a website;

Rule 10 has been incorporated with a view that the rates, prices and monthly remuneration of consultants/experts are to be known to the public, whereby public can scrutinize any overpriced rate/purchase by comparing prices for similar procurements by different departments. According to SPPRA Rule 56, non-compliance of SPPRA Rules amount to mis-procurement.

TI Pakistan has noted that the evaluation reports and the contracts award information along with BOQ rates relating to most of the recent contracts awarded by the Sindh Governor House, Karachi are not uploaded under the Contracts section on the SPPRA website. However, only 02 evaluation reports from the year 2019 are available under the Bid Evaluation Report (Annexure A)

TI Pakistan requests the MD SPPRA to take action on the violation by the Governor's Secretariat, to ensure compliance of Rule 10 by the Governor's Secretariat, as such contracts are deemed mis-procurement under SPPRA Rule 56.

TI Pakistan is striving for across the board application of Rule of Law, which is the only way to stop corruption and achieve zero tolerance against Corruption,
