	Comments by SPPRA at PPMS	Replies of SSWMB
1.	The criteria must clearly mention minimum requirement e.g. minimum amount of turn-over in terms of Rule-46(1)(a). Procuring Agency is required to extend the response time accordingly.	It is submitted that it is simple procurement of goods covered under rule-17(1) of SPPRA Rules, 2010, where SSWMB earlier in same nature of procurement processed under NIT-6/2020-21 (PPMS Serial No.T00514-20-0004) did not mentioned minimum requirement of criteria in term of rule-46(1) of SPPRA Rules, 2010 and SPPRA did not raised any objection upon minimum requirement. However, in current procurement, minimum eligibility criteria was mentioned in bidding documents to qualify by the bidders for further evaluation on technical specification.
2.	Procuring Agency has mentioned/asked "Registration with SRB" in bidding documents which are not required for the procurement of GOODS.	Thank you for pointing out. It is well noted for future compliance.
3.	Bidding documents do not contain the template of Integrity Pact as required under Rule-89. Procuring agency is required to rectify the infirmity.	It is submitted that as mentioned in SPPRA Regulations Procurements exceeding Rs.10 million for goods and works, and Rs.2.5 million for consulting services are subject to an integrity pact, as specified by Rules, between the procuring agency and suppliers or contractors or consultants. However, the instant procurement is below 2.0 million covered under rule-17(1) of SPPRA Rules, 2010
4.	SPPRA's web address for downloading bidding documents is not correct in NIT. It is www.ppms.pprasindh.gov.pk. rectification is required.	It is submitted that bidding documents were uploaded as provided under section-17(1) on PPMS for downloading by bidders through SPPRA Website (Public Portal). In addition to this these documents were also uploaded on SSWMB own Website on same date. However, as pointed out web address of SPPRA is noted for future compliance.
5.	Procuring agency is advised to rectify the infirmities generated by system.	It is submitted that the infirmities/observation generated by PPMS System is not being shown at PPMS System, kindly forward the same to P.A so that rectification of same may be done timely.
6.	Procuring agency is required to pay web- hosting charges.	It is requested that the Bill / Invoice to pay web hoisting charges may be submitted to P.A for payment.
