Sub: Violation of Sindh Public Procurement Rules 2010, Project Director-AJP, High Court of Sindh, Karachi's Quotation Notice for Supply and Installation of Computer Networking, CCTV Cameras and PABX Equipment.

This is with reference to Project Director-AJP, High Court of Sindh, Karachi's Quotation Notice, published in daily "The News" on 16th January, 2015. It is observed that the advertisement is in violation Sindh Procurement Rules 2010.


As per the advertisement, it is mentioned that, "The Sindh High Court reserves the right to reject any or all bids without assigning any reason", which is violation of Sindh Public Procurement Rules 2010, Rule No. 45. The Rule is quoted below for your reference:

45. Announcement of evaluation reports - Procuring agencies shall announce the results of bid evaluation in the form of a report giving reasons for acceptance or rejection of bids. The report shall be hoisted on website of the Authority and that of the procuring agency if its website exists and intimated to all the bidders at least seven (07) days prior to the award of contract.

The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 56, and with request to re-invite the quotation under the prescribed procedures or issue a corrigendum and extend date accordingly.
