The proofs of these practices are awarded Periodic Maintenance and Special Maintenance works on almost on double rates to Engineer's Estimates to single bidders, they disqualified not only M/s AMB & Co. but also other contractors who submitted low rates.

It is also open secret before this NIT, Director Coordination Mr. Hussain Shah was involved in mega corruption in the tenure of previous Member South Zone, and they have accommodated their favorite and partner contractors on high rates in the month of April this year. they awarded Periodic Maintenance works to single bidders on very high rates and given them unnecessary variations which caused loss of at least Rs.5 Billion to national treasure to get heavy amount of kick backs in the name of commission.
