That the appellant is a Professional Government Contractor and registered with Pakistan Engineering Council.

1. That, the above mentioned procuring agency called the above NIT where in the undersigned being interested downloaded the bidding documents from the SPPRA PPMS Website and participated in the bidding Process.
2. That, on Dated: 29-10-2024 the undersigned gave an Application No. AHK/SUK/135, for knowing the current status of an Evaluation of the Technical Proposals, and on Dated: 01-11-2024 at about 3PM, the undersigned again reached at office and met with the Chief Program Manager who openly said that he has award the Works to his chosen Contractors and pressurized the undersigned to withdraw the Tender and also openly said that he will award the Work to the undersigned in next NIT but the undersigned refused his illegal offer and said to conduct the Evaluation and opening of Bids as per SPP Rules and Regulations.
3. Thereafter the Chief Program Manager dishonestly issued a Letter on Dated: 01-11-2024 and sent the same by TCS at time 20:30 Hours at Night (Receipt Attached), and illegally and unlawfully put the Dated: 31-10-2024 on that Letter which has disclosed his ulterior motives and in that Letter No. RSU-SE&LD/ASPIRE/P&E/60-UNITS/1393/2024-25, Dated: 31-10-2024, and dishonestly mentioned it that he has Conducted the Opening of Financial Proposals on Dated: 07-10-2024 which is totally

4. That, being aggrieved the appellant approached to The Director General Planning Development & Research School Education & Literacy Department (Chairman CRC), for Redressal of Grievances against illegal acts of the Chief Program Manager and others but the meeting was not called in the stipulated time period by him which is totally illegal and unlawful act and is violation of Rule-31 of SPP Rules 2010.

Prayer

1. To Constitute meeting of the Review Committee and direct the procuring agency to terminate the bidding process of the NIT as material violation of SPP Rules and Regulations has been established.
 2. To declare the act of procuring agency of opening of the Financial Proposals without informing the undersigned is illegal and unlawful and is violation of mandatory provisions of procurements rules and regulations.
 3. To direct the Procuring agency/Chief Program Manager (RSU) to call fresh NIT by complying Rules and regulations according to its soul and spirit.
 4. To pass another order which may deem fit and proper under the Circumstances of the Appeal.
