It is also mentioned here that I had apprehension that the XEN will modify the Nit's and I clearly mentioned in my application on Para no: 08 and similarly Nit No: 02 is modified by XEN without any justification and corrigendum has been issued and uploaded on SPPRA website on dated: 25-05-2024.

Respected sir, that the XEN mentioned in his correngidum vide No: XEN/EST/CollegeHyd/180 Dated: 16-05-2024, which was uploaded on 25-05-2024 at PPMS Website, that "the correction in the name / bids cost and bid security for S.No.11 is amended / corrected as under, However the works mentioned in NIT S.No.12 to 19 are hereby withdrawn / dropped from the list".

Respected sir, the XEN violate the SPP Rules to modified the Nit and amend the eligibility criteria and XEN required unnecessary eligibility criteria and he established the terms and conditions on his wish and will to accommodate and to award the tenders to his blue eyed contractors, I also requested in my application at Para no 08 to XEN to show the A.A, release of funds to clear my apprehensions but he failed to show.

Respected sir, I have a apprehension that the XEN will again modify the above corrigendum just to engage / disturb to keep away from tenders to contractors or bidders.
