School Teacher GGP School Makli Thatta in Education Department in the year 1964 to 31.01.1995 and retired from Government Service from 01<sup>st</sup> August 1995 and got her pension up to 31.01.1999, She was died away on 25.02.1999 was transferred to her sister from 26.02.1999 to still date drawing from NBP Makli Branch Thatta said plot B-89 was transferred on 07 September 2014 while plot was already frudently transferred by Mr. Karam Ali Uqaily on 17.04.2006 and applicant also well informed through an application dated 22.04.2014 sent through TCS service NO 7007849604 dated 22.04.2014.

2. I Abdullah Memon applicant /complainant moved applications to Deputy Commissioner Thatta, Commissioner Hyderabad Division, Chief Secretary Sindh Karachi, Chairman Anti-Corruption Establishment Karachi, Home Secretary Sindh, IGP Sindh Karachi, Chairman FBR Islamabad, & Secretary Establishment Division Islamabad.
3. The Civil Bureaucracy of Sindh province and Centre protected to their Bureaucrat BS-20 of Inland Revenue service of FBR Islamabad.
4. The Defaulter Bureaucrat miss using his power & influence to anywhere in Sindh & Centre and obtained Order & decisions of his own choice to save from punishment from my first application dated 22.04.2014 where clear legal & lawful facts mentioned sent through TCS service NO 7007849604 dated 22.04.2014.
5. The defaulter misusing his power illegally to side line inquiry of Chairman E & ACE Sindh Karachi, Where he found guilty & defaulter of the case proved by IO & investigation ACE Karachi.
6. The defaulter misusing his power illegally to managed & issued fake death certificate with the connivance of Secretary Union Council Makli MR. Khair Muhammad Jhatial and Mr. Muhammad Yousif Junejo Clerk where date of death mentioned as 11.05.2009 of his own choice through third party application of MR ASGHAR ALI SHAH CNIC NO: 41308-3034075-2 R/o of alleged disputed plot B-89 unlawfully & illegally. That defaulter had received an application of third party neither relative nor concerned the matter on 31.01.2016 and fake death certificate issued on 07.11.2016 after passing of two years of sale out of plot B-89 on 07.09.2014.
7. That defaulter misusing his power illegally and issuing threats and causing harassment issuing legal notices time & again through advocate of Karachi first is 04 August 2017 second is 31 July 2019 responded on 12..08.2017 & 23.08.2019 sent though TCS service where he pressurizing and made a harassment to withdraw all complaints, applications moved to various departments of high ups, otherwise be ready for future consequence such as filling of illegal court cases etc.
8. That defaulter of the case file a suit No 69/2020 on 19 September 2020 at Additional Districts & Session Judge 6<sup>th</sup> city Court Karachi without any justification and jurisdiction as per case dairy 19 September 2020 to 17 February 2022 case was disposed of on MERIT and plaint of suit returned back / rejected his suit 69/2020 failed his misdeed.

9. That occupier of plot B-89 PIR GHULAM JEELANI R/o Makli Through his follower / Mureed Namely MOHAMMAD RAHIM SAMMON lodged FIR on 07.02.2016 at 1630 hours about illegal unlawful ground of loan etc. Same was dispose of as MERIT on 08.04.2016 by judicial Magistrate Thatta , PIR GHULAM JEELANI is running madrasa at Makli area.
10. That MR. Abdul Wahid Uqaily was nominated as defaulter of the case in the minutes of meeting of Anti-Corruption committee 1 and Chief Secretary to Government of Sindh approved & signed on 04 June 2020 in the instant matter No 21-GO(T)2015/2166-67 dated 18.09.2018 due to involvement of white color crime under section 420, 468,471,34 PPC Cheating & fraud.
11. The defaulter of the case and Occupier of property B-89 both are close friends and associated with ruling party of sindh and got influence wrong & Right in their favor for save punishment from the rule of law of the land.
12. The District Management of Thatta and police Management of Thatta did not follow the rule of law of their jurisdiction of Makli office Thatta they are well informed through applications since long from 22.04.2014 to still date.

By this order, I intend to dispose of the application U/O VII Rule 10 CPC filed by the defendant with prayer to return the plaint to the plaintiff being barred by jurisdiction under section 19 and 20 of CPC therefore this Court lacks jurisdiction to entertain the instant suit and as such it may be returned to the plaintiff to present the same before the Court of competent jurisdiction.

On notice, the plaintiff has filed objections in shape of counter affidavit.

Heard defendant in person whereas learned senior counsel for the plaintiff has chosen to remain absent as always junior counsel marked attendance in the morning and left the court as such the contents of counter affidavit to instant application is treated as arguments on behalf of plaintiff side.

I have given careful consideration to the submissions made by the defendant and gone through the contents of plaint of this suit as well as counter affidavit filed by the plaintiff side.

The plaintiff has filed the present suit for permanent injunction and damages with the following prayers:

*a. Permanent injunction restraining the defendant, his servants, agents, employees and / or subordinates from writing complaints / correspondence, any defamatory material whatsoever so also to adversely effect the reputation of the plaintiff professionally and ethically.*

b. Direct the defendant, to pay to the plaintiff a sum of Rs.100,000,00/= (Rupees Ten Million Only) towards the damages for the loss of reputation professionally and ethically, goodwill and mental agony caused to the plaintiff due to illegal acts of the defendants.

c. Cost of the suit.

d. Any other relief this Hon'ble Court deems proper in the circumstances of the case.

It is an admitted position that at the time of filing of this suit the plaintiff was residing at Lahore whereas at present he is residing at USA whereas the defendant is residing at Makli District Thatta and all the alleged defamatory letters and communication to the authorities mentioned in para 15 of the plaint are to be made by the defendant from District Thatta. It is also pertinent to mention here that most of correspondence as detailed in para 15 of the plaint are not annexed with the plaint.

Section 19 of Code of Civil Procedure 1908 speaks that:

"Whereas suit is for compensation for wrongs done to the person or to movable property, if the wrong was done within the local limits of the jurisdiction of one Court and the defendant resides, or carries on business, or personally works for gain, within the local limited of the jurisdiction of another court, the suit may be instituted at the option of the plaintiff in either of the said courts."

Section 20 of Code of Civil Procedure 1908 speaks that:

"Other suits to be instituted where defendants reside or cause of action arises."

In view of above stated facts and circumstances of this suit the cause of action accrued to the plaintiff at Thatta other than Karachi as such it is beyond the territorial jurisdiction of this Court, therefore, I find that this Court lacks jurisdiction to entertain the above suit and grant the relief claimed by the plaintiff. Resultantly, by allowing this application, the plaint of this suit is hereby returned U/o. VII Rule 10 CPC to the plaintiff to present the same before the Court of competent jurisdiction if so desired. There is no order as to costs.

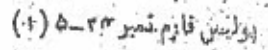

On 07-02-2016 at about 1130 hours, I along with Khuda Bux and Allah Warayo, was present near Jilani House, adjacent to the House of accused Abdullah. Accused Abdullah, Abdullah's Son, Muhammad Ali & Imran were digging in street to lay a water line. I went to them and demanded back the loan amount which was advanced to accused Abdullah. Accused Abdullah replied that he will not return the money, and do whatever you want to do against him. Meanwhile, accused Abdullah took spade from street and inflicted same on my left side of the head and due to impact of hurt I fell down. Meanwhile, Allah Warayo & Khuda Bux took me from the ground. They took me to Police Station Makli 1200 hours and my FIR was registered and thereafter I went to Hospital along with Police letter. I produce carbon copy of Police letter No.91/2016 dated 07-02-2016 at Exhibit No.4/A which is same, correct & bears my signature. In hospital I was given first aid & bandage on my injury and thereafter I returned to Police Station Makli on next day i.e. 08-02-2016 and then my FIR was registered against accused persons. I produce FIR No.15/2016 under Sections 337-A(ii), 504/34 PFC at Exhibit No.4/B, which is same, correct & bears my signature. I don't remember the date, however, accused Abdullah & Muhammad Ali were arrested by Police. Accused Abdullah was arrested near Dubai Store Makli and accused Muhammad Ali was arrested from his house. Complainant could not identify accused Imran & Muhammad Ali present in Court, however, he identified accused Abdullah present in Court.

CROSS TO MR. AJAZ JUMANI,  
ADVOCATE FOR ACCUSED

I am wearing cap of Saieen Ghulam Jilani, who is my Murshid. It is correct that I am follower of Saieen Ghulam Jilani. It is correct that other witnesses are also followers & workers of Saieen Ghulam Jilani. It is correct that I offer prayer, led by Saieen Ghulam Jilani. It is correct that I obey all commands of Saieen Ghulam Jilani. I am Mason by profession. I am still engaged in same profession and ear Rs.1000/- to Rs.1200/- per day. It is correct that accused Abdullah and Saieen Ghulam Jilani has dispute over a plot of land. It is incorrect that Saieen Ghulam Jilani pursue my present case. Amount was outstanding against accused Abdullah. I delivered cash amount to accused in presence of Nazir. I don't remember at which place I handed over cash amount to accused Abdullah. It is correct that many people from locality gathered at the time of incident. It is correct that witnesses Allah Warayo and Khuda Bux reached at spot after I fallen on ground due to impact of injury. Allah Warayo & Khuda Bux took me to Police Station in Caar (Black color) owned by Shabbir Samoon. We remained at Police Station makli for about 30 minutes. Allah Warayo & Khuda Bux were present with me in Police Station. We reached at Police Station at 1200 hours and we reached in Hospital at 1300 hours. It is correct that contents of FIR were read over to me. It is correct that only Police letter was issued on our first visit to Police Station Makli. It is correct that I was not present at the time of arrest of accused Abdullah. It is correct that I was present at the time of arrest of accused Muhammad Ali. I remained admitted in Hospital for four days. I become unconscious after sustaining injuries. I gained consciousness in Hospital. It is incorrect that i have received notice from Medical Board, where accused has challenged Medical Certificate. It is correct that Saieen



Ghulam Jilani is an influential person of the locality. It is correct that SSP, DIG & other officers visits Pir Syed Ghulam Jilani. It is incorrect that officials do not disobey the commands of Pir Jilani. It is incorrect that no such incident took place. It is incorrect to suggest that I deposed falsely I lodged FIR non 08-02-2016. I along with Allah Warayo, Khuda Bux and Nazir were present at the time of registration of my FIR. It is incorrect that I deposed falsely that I gave advanced loan to accused Abdullah. I know that accused Abdullah is an officer grade person. It is correct that Accused Abdullah is a wealthy person. Accused was laying water line adjacent to his house in Street (on right side of house of accused Abdullah). It is incorrect that I have not sustained any injury. It is incorrect that I lodged false FIR on behest of Saieen Ghulam Jilani. It is incorrect that Medical Certificate is managed under the influence of Saieen Jilani. It is incorrect that I am deposing falsely.

JUDGMENT

08.4.2016

This judgment will dispose of criminal case against accused, namely (1) Abdullah son of Muhammad Ishaque, By caste Memon, resident of House No.B-90 Makli Hashimabad Society Makli Taluka & District Thatta, (2) Muhammad Ali son of Ghulam Ali, By caste Memon resident of village Allah Bux Gandro near Society Park Opposit Jeelani House Makli Taluka and District Thatta, (3) Imran son of Ghulam Ali, By caste Memon, resident of House No.65 Nareja village Makli Taluka & District Thatta, who have been booked in FIR No.15/2016 under Sections 337-A(ii),504, 34 Pakistan Penal Code, 1860, Police Station: Makli.



Succinctly, the complainant namely Muhammad Rahim Samoon lodged FIR No.15/2016 at 1630 hours stating therein that complainant is meson by profession, one Abdullah son of Ishaque Memon reside in his neighbourhood, about 7/8 months ago Abdullah obtained loan worth Rs.1,00,000/-for one month in presence of Khuda Bux and Nazir Ahmed, but he failed to repay the loan within due time, complainant continued demanding his outstanding amount from Abdullah but was kept on hopes.

On 7.2.2016 at 1630 hours Abdullah Memonn alongwith Muhammad Ali son of Ghulam Ali Memon and Imran son of Unknown Memon were digging pipe line in front house of complainant, when he and his nephew Khuda Bux at 11-30 a.m went to Abdullah Memon and demanded the money whereupon Abdullah, Muhammad Ali and Imran abused and said they have no money, he do whatever he likes, whereupon Muhammad Ali and Imran while abusing captured complainant whereas accused Abdullah Memon caused Belcha blow on the head of complainant, his head was fractured and blood started, witnesses Khuda Bux and Allahwarayo intervened and rescued complainant from accused persons, thereafter, accused went to their houses, abusing him. Thereafter, complainant came at police station Makli, collected letter, got himself treated from Civil Hospital Makli and on issuance of Medical Certificate, he lodged the FIR, hence, this FIR.

LTI of complainant Muhammad Rahim.

Sd/- ASIP Police Station, Makli.

Police action: Contents of above shows non-cognizable offence, as such entry is made under Section 157 Cr. P. C., and same is referred to Court. Copy of the FIR is distributed under the law.

3. On completion of investigation, the Investigating Officer submitted charge-sheet No.17/2016, under Section 173 Cr. P. C., regarding offence under Sections 337-A(2), 504, 34 Pakistan Penal Code, 1860, against the present accused persons. Cognizance of offences was taken for offence under Section 337-A(ii), 504, 34 Pakistan Penal Code, 1860 and copies of statements under Section 161 Cr. P. C., and other relevant documents viz FIR, Challan, mashirnama, and statement of witnesses were supplied to the accused persons, as required under Section 241-A Cr. P. C, at Exhibit No.1. Charge against present accused was framed on 05.3.2016 at Exhibit No.2 to which they pleaded not guilty vide Exhibit No.2/A to Exhibit No.2/C respectively. Statement of process server ASI Razik Bux regarding non appearance of complainant & his P.Ws at Exhibit No.3, having produced un-served due to complainant and his P.Ws concealed themselves and avoiding to attend the court at Exhibit No.3/A and endorsement of process server at Exhibit No.3/B.

4. At trial, prosecution examined Muhammad Rahim Samoon, being complainant at Exhibit No.4, having produced police letter at Exhibit No.4/A, FIR being crime No.15 of 2016 at Exhibit No.4/B. P.W-2 Allah Warrayo Katiyar, being eye witness, was examined at Exhibit No.5. P.W-3 Nazeer Ahmed was examined at Exhibit No.6, being eye witness. P.W-4 HC Amjad Hussain was examined at Exhibit No.7. P.W-5 ASI Razik Bux was examined at Exhibit No.8 being Investigation Officer, having produced roznamcha entry No.08 at Exhibit No.8/A, Memo of incident at Exhibit No.8/B, Provisional Medicolegal Certificate at Exhibit No.8/C, Medicolegal certificate at Exhibit No.8/D, memo of place of incident at Exhibit No.8/E, Memo of arrest at Exhibit No.8/F. P.W-6 PC Ghulam Qadir Shahani was examined at Exhibit No.9. P.W-7 Dr.Ramesh Kumar Bansari(Hindu) Senior Medical Officer, Civil Hospital Thatta was examined at Exhibit No.10, having produced police letter at Exhibit No.10/A. Thereafter, the prosecution vide statement dated 02.4.2016 at Exhibit No.11, closed its evidence.





5. Statements of accused was recorded under Section 342 Cr. P. C., at Exhibit No.12 and Exhibit No.14, wherein accused prayed for innocence and prayed for justice, no accused examined themselves on oath under Section 340(2) Cr.P.C. nor defence evidence.

6. Heard the learned Assistant District Public Prosecutor and learned counsel for both accused persons.

7. From the evidence, the following points for determination was framed:

(i) Whether on 07.2.2016 at 1130 hours, near Jillani House Maldi, accused Abdullah son of Ishaque Memon, Imran Memon & Muhammad Ali Memon in furtherance of common intention attacked complainant Muhammad Rahim, and accused Abdullah hit belcha below upon the head of complainant, on which P.Ws Khuda Bux and Allahwarayo and used to filthy language, hence accused have committed offence Under Section 337-A(ii), 504, 34 Pakistan Penal Code, 1860?

(ii) What offences if any the accused, have committed?

8. Findings qua Points for determinations are:

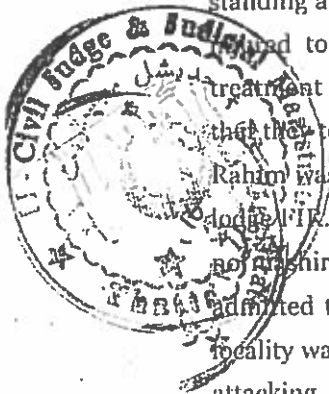
Point No.(i)	:	Not established beyond reasonable doubt.
Point No.(ii)	:	Accused persons namely (1) Abdullah son of Muhammad Ishaque, By caste Memon, resident of House No.B-90 Makli Hashimabad Society Makli Taluka & District Thatta, (2) Muhammad Ali son of Ghulam Ali, By caste Memon resident of village Allah Bux Gandro near Society Park opposit Jeelani House Makli Taluka and District Thatta, (3) Imran son of Ghulam Ali, by caste Memon, resident of House No.65 Nareja village Makli Taluka & District Thatta are acquitted Under Section 245(i) Cr.P.C, on extending benefit of doubt.



POINT NO.(i): Conscientiously examined the oral testimonies & documents produced in evidence in the shape of Memorandum of Site Inspection & Memorandum of Arrest, Provisional & Final Medical Certificates and considered the arguments advanced by learned counsel of the prosecution & accused. Careful appreciation & thrashing of evidence led by the prosecution transpire that witnesses have made material contradictions in regard to their presence at spot, time & place of exact incident, seat of injuries, time of reporting incident to police & time of arrival at hospital etc. Accused Abdullah & others have been charged with offence of intentional insult & hurt/injuries, to complainant Muhammad Rahim & such charge was denied by the accused in their pleas. The complainant, Muhammad Rahim, in his evidence described the incident that on 07-02-2016 at about 1130 hours, he along

with Khuda Bux & Allah Warayo were present near Jilani House, situated adjacent to accused Abdullah's house, where he along with his son and Muhammad Ali & Imran were busily laying a waterline. Complainant deposed that he went to them and demanded return of loan amount from Abdullah, but he refused to return the amount instead inflicted spade blow on left side of his head, consequently he fallen on ground and meanwhile Allah Warayo & Khuda Bux took him to Police Station Makli at 1200 hours where his FIR was lodged & Police letter No.91/2016 was issued. Complainant further deposed that in Hospital, he was given first aid & bandage and thereafter he returned to Police Station Makli on 08-02-2016 and his FIR No.15/2016 under Sections 337-A(ii) & 504/34 PPC was registered. P.W.-1 deposed that accused Abdullah & Muhammad Ali were arrested by Police from Dubai Store & House respectively. P.W.-1 could not identify accused Imran & Muhammad Ali present in Court. Perusal further reveals that in cross examination, complainant Muhammad Rahim admitted that his is staunch devotee of spiritual leader Pir Jilani and further stated that he don't know where & on which date he extended loan to accused Abdullah. In contradiction to his statement in examination in chief, complainant in cross examination stated that witnesses Allah Warayo & Khuda Bux reached to rescue him after he fallen on ground. In cross examination, complainant stated that witnesses Allah Warayo & Khuda Bux took him to Police Station in Black Color (Car) owned by Shabbir Samoon and they remained in Police Station for 30 minutes and further stated that they reached at Police Station Makli at 1200 hours and they reached Hospital at 1300 hours. The complainant, in contradiction to his statement that he returned to Police Station Makli on 08-02-2016, stated that he remained admitted in Civil Hospital Makli for four days and in cross examination further admitted that he was not present at the time of arrest of accused Abdullah and Muhammad Ali.

10. To strengthen the case, prosecution examined Allah Warayo son of Ahmed Ali, as P.W.-2 at Exhibit No.5, wherein, he deposed that on 07-02-2016 at 1130 hours, he along with Khuda Bux were working as labourer adjacent to Jilani House and on seeing rush of people they went there and saw that Abdullah Memon is standing and accused Muhammad Ali and other persons were holding Muhammad Rahim and meanwhile accused Abdullah caused Balcha/Spade blow to Muhammad Rahim on left side of his head and at the time of attack, they were standing at a distance of 20 feet. P.W.-2 deposed that he along with Khuda Bux took injured to Police Station Makli and Police issued Police letter only for medical treatment and no other document was prepared at Police Station. P.W.-2 deposed that they took injured to Civil Hospital Makli and on 11-02-2016 injured Muhammad Rahim was discharged from hospital and thereafter they went to Police Station and lodged FIR. P.W.-2 deposed that on 12-02-2016 Police inspected place of incident but no Mashirnama of site inspection. In cross examination, like complainant, P.W.-2 admitted that he is devotee of Pir Jilani. P.W.-2 stated that no other person from locality was present at the time of incident, except accused and he saw accused while attacking Muhammad Rahim from some distance. P.W.-2 stated that they took



injured to Police Station in a Rikshaw and further stated that injured was unconscious in Police Station Makli, although, in reply to any other question he stated that he don't know that at the time of incident was conscious or not. P.W.-2 further stated that injured gained consciousness after two hours in Hospital.

11. In regard to advancement of loan to accused Abdullah by complainant Muhammad Rahim, prosecution examined one Nazeer Ahmed son of Misri as P.W.-3 at Exhibit No.6, stated therein that on 07-02-2016 at about 1130 hours, Muhammad Rahim came to him and he demanded Rs.100,000/- from accused Abdullah. Due to said dispute, Abdullah, Muhammad Rahim had altercation and during scuffle Muhammad Rahim sustained injury and Khuda Bux & Allah Warayo took injured to Police Station and on 12-02-2016 at 1200 hours Police came at place of incident and recorded his statement. In cross examination, P.W.-3 Nazeer admitted that he is devotee of Pir Jillani and obey his commands. In reply to suggestion, he denied that injured Muhammad Rahim did not sustain any injury in his presence.

12. To substantiate arrest of accused Abdullah, prosecution examined Amjad Hussain Head Constable, as P.W.-4 at Exhibit No.7, wherein, he denied arrest of accused Abdullah from Makli Park, rather, stated that accused Abdullah was called from his house over phone and was arrested in Police Station and mashirnama of arrest was prepared at Police Station. The prosecution declared witness as hostile, and in cross examination prosecutor could not shake the credit of the witness/mashir.

13. ASI Razik Bux Jokhio was examined as P.W.-5 at Exhibit No.8, being Investigating Officer, wherein, he deposed that on 07-02-2016 at 1200 hours, complainant Muhammad Rahim Samoon came at Police Station and he examined injuries, prepared Memo of Injuries & issued Police letter for medical examination and made entry No.6 in the Roznamcha. P.W.-5 deposed that on 11-02-2016 injured Muhammad Rahim again reported at Police Station with Provisional Medical Certificate, Exhibit No.8/C and Final Medical Certificate, Exhibit No.8/D and on his statement he lodged FIR No.15/2016 under Sections 337-A(ii), 504/34 PPC, Exhibit No.4/B. P.W.-5 deposed that on 12-02-2016 at about 1030 hours, he inspected place of incident & prepared Memorandum of Site Inspection, Exhibit No.8/E and on 14-02-2016 accused Abdullah was arrested from Makli park in presence of HC Amjad & Ghulam Qadir under Memo of Arrest, Exhibit No.8/F.

14. To substantiate arrest of accused Abdullah, prosecution also examined P.C. Ghulam Qadir, as P.W.-6 at Exhibit No.9, wherein he deposed that on 14-02-2016 accused Abdullah was arrested near Makli Park, in presence of HC Amjad Hussain and he verified contents of Mashirnama of arrest, Exhibit No.8/F.

15. Lastly, prosecution examined Dr. Ramesh Kumar as P.W.-7 at Exhibit No.10, wherein he stated that on 07-02-2016 at about 1155 hours, injured Muhammad Rahim came at Civil Hospital Makli along with Police letter No.91 and he examined



injured and found a lacerated wound on left frontal bone of skull at about 4cmx1cm partially exposing bone with irregular margin and he advised x-ray and he issued provisional & final medical certificates qua injuries. In cross examination, he admitted that medical certificates have been challenged before Medical Board where injured did not appear on two dates.

16. The juxtaposition analysis of evidence of complainant & eye-witnesses shows that they have contradicted each other on material aspects & broad features of the prosecution story. The complainant in FIR stated that he has advanced Rs.100,000/- to accused Abdullah son of Ishaque Memon about 7/8 months ago in presence of Allah Dino Samoon & Nazeer Ahmed Misri Bhatti, however, in his statement before this Court, he has skipped said features of the case. In support of loaning to accused Abdullah Memon, one Nazeer Ahmed son of Ishaque Memon was examined as P.W.-3 at Exhibit No.6, and P.W.-2 in his evidence has not uttered a single word qua advancement of Rs.100,000/- by complainant to accused Abdullah, rather, he portrayed himself as eye-witness of the incident dated 07-02-2016, although, he has not been cited as eye-witness of the incident by complainant or eye-witnesses, therefore, presumption would that he is deposing falsely before this court & has made conflicting statement viz-a-viz his statement under Section 161 Cr. P. C. It is settled cannon of criminal jurisprudence that witness making conflicting statement is not a witness of truth, in this regard I am fortified with case of Qazi @ Dost Muhammad Versus the State reported as 2014 P.Cr. L. J, page 611, wherein, Hon'ble High Court of Sindh, held that"

**"One who is held to be telling lie may not be believed to be speaking truth when his such statement is in a single breath unless otherwise proves else as the same may take away the golden rule of benefit of doubt on which safe criminal administration of justice rests."**

17. The perusal reveals that complainant deposed that accused Abdullah took a spade from street & inflicted same on his left side of the head and such attack was made in presence of Allah Warayo & Khuda Bux. The complainant in examination in chief deposed that he along with Khuda Bux & Allah Warayo were present near Jillani house when accused attacked him, whereas, in cross examination he stated that witnesses Allah Warayo and Khuda Bux reached at spot after he fell on ground due to impact of injury. The above fact show that the complainant has made conflicting statements with regard to presence of eye-witnesses Allah Warayo & Khuda Bux, thus, creating doubt in the prosecution story.

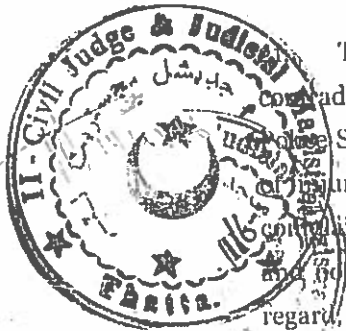
In regard to shifting of injured to Police Station & then to Civil Hospital, complainant Muhammad Rahim, stated that Allah Warayo & Khuda Bux took him to Police Station in Black Color Car, whereas, witness Allah Warayo stated that they shifted injured Muhammad Rahim to Police Station in a Rikshaw, owned by Jahan & arranged from locality. Both complainant & witness Allah Warayo, has given different account & different kind of vehicle wherein complainant was shifted



to Police Station Makli, but to add further insult to injury, witness Nazeer Ahmed stated that injured Muhammad Rahim was shifted to Police Station Makli on a motorcycle, thus, this aspect of the prosecution story makes case as doubtful & unbelievable.

19. Insofar as time of incident, time of reaching at Police Station Makli & time of arrival at Civil Hospital Makli, complainant deposed that incident took place at 1130 hours, and they reached at Police Station Makli at 1200 hours and then reached at Civil Hospital Makli at 1300 hours. The eye-witness Allah Warayo, deposed that incident took place at 1130 hours, they reached at Police Station Makli at 1200 hours and they remained at Police Station Makli for 30 minutes. On the contrary, Provisional Medical Certificate No.1424 dated 08-02-2016, Exhibit No.8/C shows that incident took place at 1100 hours, and injured arrived at Civil Hospital Makli at 1155 hours, thus, material contradictions are floating on surface of the evidence.

20. In regard to seat of injuries, complainant Muhammad Rahim deposed that he sustained injury of left side of the head and stated that no mashirnama of injuries was prepared on 07-02-2016 when he arrived at Police Station Makli, and such non preparation of Memorandum of Injuries is corroborated by eye-witness Allah Warayo, who per column-6 of the charge-sheet is also a mashir of the Memorandum of Injuries. The said Memorandum of Injuries is produced by Investigating Officer, ASI Razik Bux at Exhibit No.8/B, however, factum of such preparation of Mashirnama of Injuries has been denied by complainant & mashir, who's LTI has been affixed on Exhibit No.8/B. In the circumstances, the veracity of Mashirnama of Injuries, Exhibit No.8/B is not proved through reliable & confidence inspiring material as well as evidence. Although, memorandum of Injuries, Exhibit No.8/B & Provisional & Final Medical Certificates, Exhibit No.8/C & Exhibit No.8/D are corroboratory form of evidence, and same cannot be alternate to the oral testimony of injured, but, such material documents are vital to establish the prosecution story. Moreso, Medical evidence, could never be primary source of evidence for the crime itself, but was only corroborative which could confirm the ocular evidence with regard to the seat of injury, nature of injury and kind of weapons used in the occurrence; and it could not connect accused with commission of crime, and in observing this, I am fortified with the case of *Allah Diwayo versus The State*, reported at 2012 P.Cr. L.J. 1089.



The oral testimonies of complainant & eye-witness Allah Warayo, itself are contradictory and same also do not tally with time of incident, time of arrival at Police Station, Time of Arrival at Civil Hospital & consciousness & unconsciousness of injured, thus, no reliance could be placed on un-corroborative evidence of complainant & witnesses. It is settled law that credibility of witness which matters more injuries of his person to give him status of truthful witness. In this regard, I am guided by case of *Qazi @ Dost Muhammad Versus the State* reported as 2014 P.Cr. L. J, page 611, wherein, Hon'ble High Court of Sindh, placing reliance on case of *Muhammad Pervez & others V. The State* (2007 SCMR 670), held that"

**"Witness---Injured witness---Credibility---Principle---  
Credibility of witness which matters and not mere injuries  
on his person to give him status of truthful witness."**

22. There are so many contradictions in between the evidence of complainant as well as eye witnesses. In view of above discussion reflect that the evidence is full of contradictions, inconsistencies, improvements & exaggerations, thus I am of considered view that there is no iota of evidence, regarding the happening of incident as such, the Point No.(i), as such, is answered as "not proved".

23. **Point No.(ii):** Upshot of the above discussion and decision, is that the prosecution has not been able to establish its case beyond reasonable doubt, as such, the accused, as the prosecution story is full of contradictions, inconsistencies, discrepancies and lacunas and it is settled law that a single infirmity creating reasonable doubt in the mind of a reasonable and prudent person regarding the truth of charge, would make whole case doubtful in the prosecution. In this regard, I am fortified by judgment of Hon'ble Division Bench of Sindh High Court, comprising of Justice Shahid Ali Bajwa and Justice Muhammad Ali Mazhar, in case of Tanveer @ Rabail versus The state reported as 2012 YLR 2026, held as"

*"Rule of benefit of doubt, described as the golden rule, was essentially a rule of prudence which could not be ignored while dispensing justice in accordance with law. Rule was based on maxim "it was better that ten guilty persons be acquitted rather than one innocent person be convicted". Said rule occupied a pivotal place in the Islamic Law and that was enforced rigorously, in the saying of the Holy Prophet (PBUH) "than the mistake of Qazi (Judge) in releasing a criminal was better than his mistake in punishing an innocent". Both the expressions "proof beyond a reasonable doubt" and "presumption of innocence", were to be read together as one unit. Single infirmity, if creating reasonable doubt in the mind of a reasonable and prudent person regarding the truth of charge, would make whole case doubtful. Accused was the most favourable child of law and every benefit of doubt would go to him regardless of fact whether he had taken any such plea or not"*

as such, the accused (1) Abdullah son of Ishaque Memon (2) Muhammad Ali son of Ghulam Ali Memon (3) Imran son of Ghulam Ali Memon, are acquitted from the charge under Section 245(i) Cr. P. C. The accused are present on Bail, their bail bond are discharged.
