1. That, the Project Director, (PMU) Prisons Department Karachi Engr, Qazi Asim Naeem, has invited NIT Vide No. TC/PD/PMU/TENDERS/2023-24/2870, DATED: 03-04-2024 Containing Fifteen (15- works), (Photo Copies of Nits are attached).
2. That Sir, I had applied to participate in the above NIT through application vide our Ref: No. 497/2024 dated 26.04.2024. Pay orders for Tender Fees shown against each work in favour of the Procuring Agency / Project Director, (PMU) Prisons Department Karachi, and other relevant documents as per requirement of the NIT. (Photo copies of Application, pay orders are attached).

Further, the issuance date, receipt and opening of tenders are fixed on dated 10.05.2024, and received back on 10-05-2024, on 26-04-2024 I approached to the office of undersigned for issuance of the Standard Bidding Documents (SBD) / Tender Documents for the above mentioned Nit, but, they totally refused to oblige and said that we could not issue the tender unless the approval and signature of Project Director, (PMU) Prisons Department Karachi Engr, Qazi Asim Naeem. It is sheer violation of the SPPRA RULE -23 (1 & 2). However, the Procuring Agency is bound to issue the tender / bidding documents as per rules. Therefore, the authority and department are requested to take stern action against the Procuring Agency (PA) as per law.
