

NOTICE FOR HEARING

HEARING IN THE MATTER OF REQUEST FILED BY K-ELECTRIC REGARDING MONTHLY FUEL CHARGE ADJUSTMENT FOR THE MONTH OF JANUARY 2023 UNDER MULTI YEAR TARIFF (MYT) 2017-2023 & QUARTERLY ADJUSTMENT FOR THE QUARTER ENDING DECEMBER 2022 UNDER MULTI YEAR TARIFF (MYT) 2017-2023

1. Decision of the Authority in the matter of Multi-Year Tariff (MYT) petition of K-Electric Ltd has been notified vide SRO No. 576(I)/2019 dated May 22, 2019. The MYT determination prescribes mechanism for adjustment in the MYT on monthly & quarterly basis.
2. K-Electric, accordingly, filed its request for monthly Fuel Charges Adjustment (Own and Power Purchases) for the month of January 2023 as tabulated below;

3. K-Electric has also filed its negative quarterly adjustment request for quarter ending December 2022 as tabulated below;

Oct - Dec 2022	(7.3660)

 - i. Whether the requested Fuel Price variation is justified?
 - ii. Whether the requested Quarterly variation is justified?
 - iii. Whether K-Electric has followed the merit order while giving dispatch to its power plants as well as power purchases from external sources?
