Subject:- NOTICE OF HEARING REGARDING POLICY GUIDELINES UNDER SECTION 31 OF NEPRA ACT 1997, FOR RECOVERY OF STAGGERED FUEL CHARGES ADJUSTMENT APPLICABLE FOR THE MONTHS OF AUGUST AND SEPTEMBER 2022

- 1. All stakeholders, interested/affected persons and the general public are informed that Federal Government has filed Policy Guidelines under section 31 of the NEPRA Act, 1997, for recovery of staggered Fuel Charges Adjustment applicable for the months of August and September 2022, of XWDISCOs and K-Electric, in the period of eight (08) months starting from March 2023 to October 2023 in accordance with the recovery rates for XWDISCOs and K-Electric consumers respectively as detailed below:

Recovery of Deferred FCAs - XWDISCOs

Table with columns: Deferred FCAs (Jun-22, Jul-22, Total) and Recovery in Mar-Oct (8 Months) - Rs/kWh (Mar-23, Apr-23, May-23, Jun-23, Jul-23, Aug-23, Sep-23, Oct-23, Total). Rows include Domestic Protected (000-200), Non-protected (000-200), Non-protected (201-300), and Private Agricultural.

Note: The above rates shall be proportionately applicable on the units of respective months, whose FCA was deferred i.e. June & July and the recovery of deferred amount shall be made in 8 months period i.e. Mar-23 to Oct-23. This tariff increase shall not apply on the consumption of Mar-23 to Oct-23.

Recovery of Deferred FCAs - K-Electric

Note: The above rates shall be proportionately applicable on the units of respective months, whose FCA was deferred i.e. May, June & July and the recovery of deferred amount shall be made in 3 months period i.e. Mar-23 to Oct-23. This tariff increase shall not apply on the consumption of Mar-23 to Oct-23.


