This is with reference to subject tender inquiry. We would like to request to your good self as under:-


1. This was after the advertisement of tender notice by M/S SBKWU-QUETTA for the supply of tyres for Buses and Coasters. Due for opening on: 18-04-2023. We immediately contacted with the procuring agency for these tender documents and requested the procuring agency for issuing us tender documents immediately vide e.mail and letter dated: 03-04-2023 through TCS courier vide receipt no:- 41424596712 dt:- 03-04-2023 and we enclosed all required documents and tender fee Rs.1000/- with courier charges Rs.500/-. This letter was received by Mr. Javed on Dated:- 05-04-2023 at 12:34 as per tracking of TCS.
2. After that we requested to the procuring agency through e-mail reminders on Dt:- 07-04-2023, Dt:- 10-04-2023, Dt:- 12-04-2023 also tried to contact on the available phone numbers for this tender inquiry documents, but all in vain as no documents received by us till 17-04-2023.
3. That at last, we received tender but incorrect tender documents on Dt:- 19-04-2023 after the opening date. These documents are for the procurement of lubricants instead of procurement of tyres which are also not relevant to the purchase of tyres. These documents were dispatched on Dt; 17-04-2023 from Quetta through TCS courier receipt no:- 6200259319 and was received by us on Dated:- 19-04-2023 after the opening date of this tender.
4. That all documents should be available immediately as per PPRA rule and also these should be available on the website of the PPRA & Buyer's website as per NAB's instructions vide letter No. 5-2(75)Pre/A&P/NABHQ/2013 Dated: 08-01-2014, Instructions of TIP (attached HEREWITH).
5. But bidding documents were not provided to us immediately and also not available on the website in a downloadable format, which is a violation of PPRA rules and falls under mis-procurement.

PPRA's Rule No: 23 - Bidding documents:

- (1) Procuring agencies shall formulate precise and unambiguous bidding documents that shall be made available to the bidders immediately after the publication of the invitation to bid.

6. That the whole action is not as per procurement rules and NAB's instructions.
7. We requested many time vide letters dated:- 21-04-23, , 26-04-23 to the procuring agency for the extension of the opening date of tender and issuing us correct tender documents but all-in vain.

It is therefore most humbly requested to please probe into the matter and pass instruction to M/s **SBKWU**, Main Campus, Brewery Road, **QUETTA to extend the opening date of this tender and issue us correct tender documents and declare all proceeding as mis-procurement** in the best interest of public exchequer and for widest, healthy, fair, economical, transparent competition and allow us to participate in this tender inquiry as we always quoted rock bottom prices and win many tenders due to which government departments safe millions of rupees.

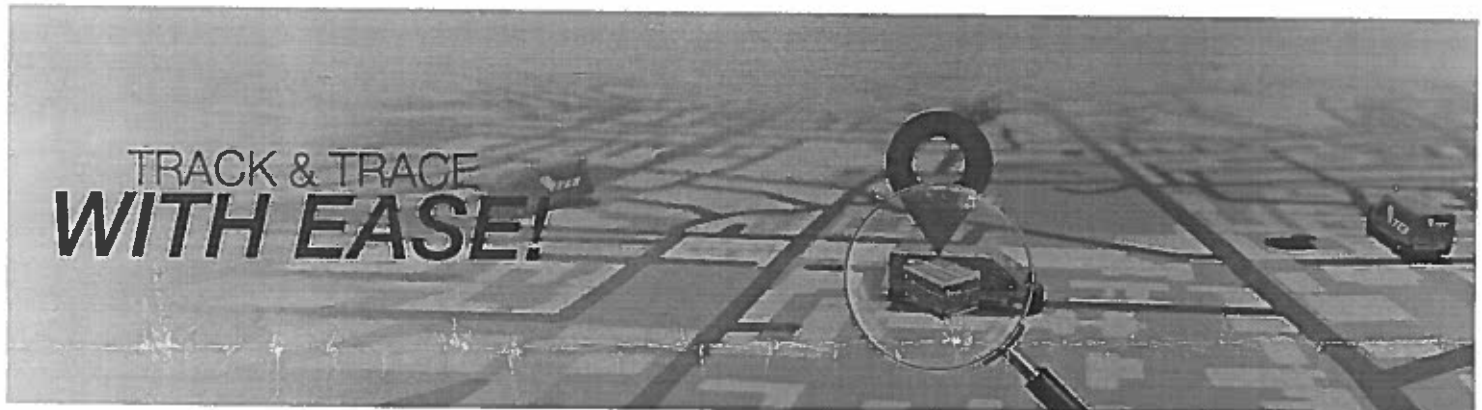
