I have been applying for daily wagger job since 2021 in the SPPRA department however no reply is being given to me on the other hand SPPRA has appointed lots of people on contingency & are refusing me.

They are fill vacant post on direct contracting from many years. I have sent many application for Job on SPPRA through registered post and courier, But SPPRA did not consider my application since 2021 but filled vacant 25 posts from BPS-5 to BPS-15 with Rs. 80,000 to 100,000 salary. On daily wages government department can not hire directly on BPS-5 to BPS-15 without Advertise and can not give this such amount of salary.

However, Sindh government pay fix salary to contingent employees fixed Wage like 30000 rupee but sppra also pay special allowance to contingent employee which is against rules / policy of Sindh government. MD regularize the contingent staff through Board without any advertising the post and without any written test / interview and SPPRA Board has no power to regularize the employee without advertising the post and not follow the policy issued by SGA&CD for recruitment.

kindly take serious action against sappra for illegal appointments and without publishing advertisement, test & interview as well as not considering my application in this regard.

Consider my application for Job in SPPRA like others people in SPPRA which have reference and connection with bureaucrats I am poor and I don't have any reference like people working their on direct contracts from years



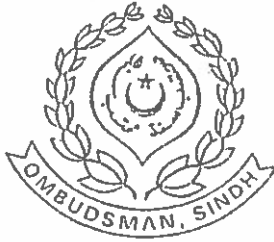

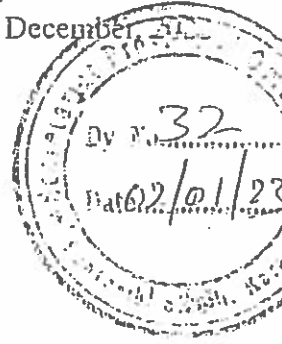
