That Sir, the Executive Engineer Highways Division Jacobabad invited the Tenders / Bids vide No. TC/G-55/275 / 2023 dated 30/03/2023 under "Single Stage Single Envelope" bidding procedure posted at the website of SPPRA-PPMS on dated 12.04.2023 containing thirty six (36-Work) of development works with total estimated cost (Rs.282.560 Million (Photo copy of NIT is attached) for kind perusal.
02. That Sir, we applied to be participated in the above said NIT for the works @ Serial # 21 , 23 , 24 through bids down loaded from the website of SPPRA-PPMS and submitted to the Procuring Agency / XEN Highways Division Jacobabad by M&P Courier Service vide Receipt # 171000861800 dated 26.04.2023 received by one (SIKANDAR ALI BHUTTO) of his office on same day i.e 26.04.2023 12:00 AM along with Bid Security, Pay Orders, Company Profile etc (Photo copies are attached) for kind perusal.

That Sir, the date of submission and opening of tenders / bids were fixed on **26.04.2023 (Wednesday) at 1:00 PM & 2:00 PM** as per schedule of NTT, in this regard the Authorized Representative of this office was approached in the office of the Procuring Agency / XEN Highways Division Jacobabad on the date of submission / opening of bids on dated **26-04-2023 at 1:00 PM**, but there was no any single Member of Procurement Committee (PC) available in the office to make the tendering process in transparent manner. All the contractors protested against such injustice due to such negligence and malpractices of the Procuring Agency in the instant procurement, for which the SPPRA may kindly take its strict notice of violations of Authority's rules and proceed against responsible persons involved in the grand corruption and commission in accordance with the rules.

04. That Sir, the Procuring Agency / XEN Highways Division Jacobabad, absolutely failed to open the sealed envelopes to announce the results in presence of the bidders as per requirement of Authority's Rule, which is clear violation of the Rules and clear favouritism with particular persons already managed by the XEN and its Members, for which the NAB may kindly take its strict notice and proceeded against the concerned XEN and Members of the Procurement Committee in accordance with the rules and proceed against the delinquent persons involved in the matter.

05. That Sir, the Bid Evaluation Report (BER) of the said work has been posted at the website of SPPRA-PPMS on dated **04.05.2023 (Saturday)** by the XEN Highways Division Jacobabad accepted the highest work **21** bid of one **M/S AL-RIAZ CONSTRUCTION CO. at Rs.6,729,754/=** and also other work serial **23** awarded the same firm highest accepted at **Rs.8,825,902/=** the other work serial **24** accepted the highest work **21** bid of one **M/S M. ANWAR & CO. at Rs.6,882,583/=** They have been managed by the Procuring Agency ulterior method through illegal means, for which a detailed enquiry needs to be conducted against responsible persons as per law

That Sir, the Procuring Agency has posted the old Notification of Complaint Redressal Committee (CRC) under **No.E&A(W&S) 3-9/91-2013**: dated **18th May, 2021** issued by Secretary Works & Services Department Karachi which has expired on **30th June, 2021**. The current Notification of CRC was required to be posted by the Procuring Agency in terms of **Rule-31(1) of Sindh Public Procurement Rules, 2010 (Amended 2019)**, but the Procuring Agency has absolutely failed to do so (Photo copy of old Notification of CRC is attached).

07. That Sir, the Complaint Redressal Committee (CRC) does not comprise an independent professional from the relevant field concerning the procurement process in question, as required under **Rule-31(2)(b) of Sindh Public Procurement Rules, 2010 (Amended 2019)**, for which the Authority and Chairman (CRC) may take its notice.

08. That Sir, there are several infirmities / observations raised by the SPPRA at its website through system generated on dated **17-04-2023**, but the Procuring Agency has absolutely failed to rectify the same prior to opening of bids, for which the Authority may please take its strict notice and proceed against responsible persons for non compliance of the Authority's rules (Photo copy of observations detailed list is attached).

09. That Sir, the Procuring Agency / XEN Highways Division Jacobabad wants to award these all works of NIT worth **Rs.282.560 Millions** to his favourite and blue eyes contractors / firms on the basis of huge bribe, political influence and do not wants to make open competition in transparent manner as per requirement of **Sindh Public Procurement Regulatory Authority Rules, 2010**. Thus clear violation has been made by the Procuring Agency/XEN of the Authority's Rules in the tendering process, for which NAB may kindly take its notice and proceeded against the responsible persons involved in the grand corruption in accordance with the rules.


