Dear sir I hope this complaint finds you well. I am writing to a complaint regarding the violation of PPRA rule no: 15.2 of submission of bid by the XEN Central Civil Division Pak PWD Hyderabad.

Respected sir, I undersigned owner of M/S Arman Developers Construction Company, I have applied for the tenders which is published in daily newspapers as well as hosting in PPRA Website then after I submitted the application along with the cost for issue me the tender documents then the XEN central Civil Division Pak PWD Hyderabad issued me a bidding / tender documents.

Respected sir, I submitted and courier my bidding documents along with bid security and other relevant documents to the XEN Central Civil Division Pak PWD Hyderabad on dated: 07-05-2024, as per the PPRA Rule No: 15. 2 of Submission of bid, but he refused / rejected to accept my bidding documents through courier services and I received back my bidding documents at my office address.

Respected Sir, I have informed to GRC on dated: 08-05-2024, through my complaint no: 240/2024, and same was received in your good office on 09-05-2024, that the XEN Central Civil Pak PWD Hyderabad is violating the rules of PPRA but still no any action taken by your good office and continuously he is violating the rules set by the PPRA.

Respected sir, my information / complaint regarding violation of PPRA rules by XEN Central Civil Division Pak PWD Hyderabad, just for stopping XEN central Civil Division Pak PWD Hyderabad from violating the rules of PPRA as well as violation of government rule because he is not competent / above the law to amend the rules, after my complaint to GRC on dated: 08-05-2024, but on dated: 09-05-2024, he issued the corrigendum in back date "THAT COURIER SERVICES WILL NOT BE CONSIDERED". Vide Corrigendum no: EE/HCCD/Hyd/150 hyd Dated: 07-05-2024 same are published on dated: 10-05-2024, in Dawn Newspaper and Daily Khabrain as well as on dated: 09-05-2024 on PPRA website.

Respected Sir, this is the evidence that according to PPRA rule no 15.2 of submission of bid is only that "BIDS SUBMITTED THROUGH TELEGRAPH, TELEX, FAX OR EMAIL SHALL NOT BE CONSIDERED" but he amend the rules as per his wish without any justification, if the correndigum was issued on 07-05-2024 then why he published this Correndigum in newspaper on dated 10-05-2024 and PPRA website 09-05-2024.

Respected sir, I have a apprehension that, he issued this correndigum just to trying to award the contract to his blue eyed persons after taking the huge bribe under the table and keeping me away to participate in nit's.

Respected sir, the XEN Central Civil Pak PWD Hyderabad, invited so many Nit's and always he follow the PPRA rule no: 15.2 of Submission of bid, that contractors have to submit their bidding documents by courier but this time he fail to do so as per his wish without any clarification / justification and without mentioning the PPRA rule that on which rule he is competent to do not accept the bidding documents by registered courier services.

Respected sir, it is requested that kindly clarify that there is any other rule except the PPRA rule No: 15.2 of submission of bid, that the bidders cannot submit their documents by courier services.

In light of this situation, I urge your committee to conduct a thorough investigation in to the matter. I seek resolution, including acceptance of my bidding documents or a detailed explanation for the rejection.

Additionally, I request measures to prevent such incident from accruing in the future, ensuring fairness and adherence to establish procedures otherwise I have a right to approach to the competent court of law if your good office did not justify / clarification to me that why my bidding documents was rejected and not accepted through courier services as per the PPRA rule no 15.2 of submission of bid.

Your prompt attention to this matter is highly appreciated.

I followed the rule No: (D. Submission of Bid) Clause IB.15 (15.2) of PPRA and on dated: 07-05-2024, with receipt no: 2068520163 to 2068520166 , 2068520168 & 2068520170 to 2068520178, I diligently dispatched the necessary bidding documents / tender documents to the XEN Central civil Division Pak PWD Hyderabad designated address as per the outlined procedure.

Respected sir, when i check my tracking Id on TCS website i dismay found that the courier services returned the tender documents to me and indicating that Receiver Refused To Accept Shipment from the Department Central Civil Division Pak PWD Hyderabad.

This turn of events his not only caused me inconvenience but has also raised significant concerns about the Integrity and transparency of the bidding process.

Despite my attempts to seek clarification from the department, I have yet to receive a satisfactory explanation for the rejection.

In light of this situation, I urge your committee to conduct a thorough investigation in to the matter. I seek resolution, including acceptance of my bidding documents or a detailed explanation for the rejection.

Additionally, I request measures to prevent such incident from accruing in the future, ensuring fairness and adherence to establish procedures.

Your prompt attention to this matter Is highly appreciated.

Thank you for your assistance in resolving this issue.

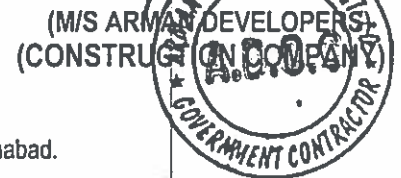
