REQUEST FOR REDRESSAL OF GRIEVANCES AND SETTLE THE DISPUTE UNDER RULE -48, COMPLAINT AGAINST EXECUTIVE ENGINEER, CENTRAL CIVIL DIVISION PAKISTAN PWD HYDERABAD AND HIS CASHIER REGARDING NON ISSUING OF TENDERS / BIDDING DOCUMENTS TO MY COMPANY WHICH IS CLEAR VIOLATION OF PPRA RULE -23 (1 & 2) OF PUBLIC PROCUREMENT RULES, IN THE TENDERS (NIT # EE/HCCD/HYD/ 111, DATED: 08-04-2024, PPRA ID # TS536959E ON DATED: 09-04-2024 & (NIT # EE/HCCD/HYD/ 112, DATED: 08-04-2024, PPRA ID # TS536983E ON DATED: 15-04-2024).

R/Sir,

1. That, the Executive Engineer, Central Civil Division Pak PWD Hyderabad has invited 02 NITs Vide No. EE/HCCD/Hyd/ 111, Hyd Dated: 08-04-2024 Containing Thirty Six (36- works), 2nd Nit No. EE/HCCD/Hyd/ 112, Hyd Dated: 08-04-2023 Containing Seventeen (17-works), (Photo Copies of Nits are attached).
2. That Sir, we had applied to participate in the above NIT's through application vide our Ref: No. 222/2024 dated 17.04.2024 & Ref: No. 224/2024 dated 17.04.2024. Pay orders for Tender Fees shown against each work in favour of the Procuring Agency / XEN Central Civil Division Pak PWD Hyderabad and other relevant documents as per requirement of the NIT. (Photo copies of Application, pay orders are attached).
3. Further, the issuance date, receipt and opening of tenders are fixed on dated 30.04.2024, and received back on 02-05-2024, on 17-04-2024 I approached to the office of undersigned and met with the concerned cashier for issuance of the Standard Bidding Documents (SBD) for the above mentioned Nit, but Mr. Rashid Soomro, concerned cashier, totally refused to oblige and said that he could not issue the tender unless the approval and signature of Engr, Ghulam Mustafa Laghari, XEN Central Civil Division Pakistan PWD Hyderabad. It is sheer violation of the PPRA RULE -23 (1 & 2). However, the Procuring Agency / XEN are bound to issue the tender / bidding documents as per rules. Therefore, the authority and department are requested to take stern action against the Procuring Agency (PA) and his Tender Clerk / Cashier as per law.
