With reference to above subject NIT, you have encorporated condition No.3, that we are re-producing here under:-

"The applicant firm must possess the valid Electrical Licence issued by Electrical Inspector Islamabad Region under Electricity Act. "

As such above condition require justification, because you are Civil Engineer of Pakistan P.W.D., and if Electrical work you have added in the NIT, then the same will have to be carried out, supervised by Electrical Engineer of Pak. P.W.D., where as Pak. P.W.D., is a Federal Department, hence Executive Engineer (E/M) is competent to Execute, Supervise and inspect such type of E/M work at his level or otherwise delete E/M work from Civil NIT. (Schedule of works), in this connection refer the Electricity Act-1910, Rule-20 (Photo copy attached) and M/S. WAPDA/IESCO have to accept the wiring test report submitted to them by any Executive Engineer E/M of Pak. P.W.D., Islamabad, as such Pak. P.W.D., execute the work on behalf of Federal Government and Electrical Engineer, is authorized to supervise the work and issue wiring test report at his level and not the contractor etc and besides above it is for your information that Electrical Contractors License issued to the contractors from any Provinces being contractor of Federal Department and on that basis, PEC register the Electrical contractor accordingly in different specialized fields which is also valid in all provinces.
