Subject: Violation of PPRA Rules 2004, Projector Director, Project Management Unit (PMU), Ministry of Federal Education and Professional Training, Islamabad's Request For Proposal (RFP) Notice for "Consultancy Services for Detailed Construction Supervision for the Project Provision of Basic Educational Facilities In Educational Institutions of ICT Under FDE"

Dear Sir.

This is with reference to your tender notice appeared in daily 'Jang' newspaper on 12th July'23. The said advertisement is in violation of Public Procurement Regulatory Authority (PPRA) Rules 2004, Rule 13 'Response time'.

In the said tender notice, 15 days of response time is not given as the submission/ opening of bids is on 21.07.23, which is five (5) days less and does not fulfill the fifteen days of response time as per PPRA Rules 2004. Hence, it is a violation of Rule No. 13 of PPRA Rule 2004.

The Rule is quoted below for your reference;

13. Response time.- (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the individual procurement's complexity, availability and urgency. However, under no circumstances the response time shall be less than fifteen ***days for national competitive bidding and thirty ***days for international competitive bidding from the date of publication of advertisement or notice.

All advertisements or notices shall expressly mention the response time allowed for that particular procurement along with the information for collection of bid documents which shall be issued till a given date, allowing sufficient time to complete and submit the bid by the closing date:

Provided that no time limit shall be applicable in case of emergency.

- (2) The response time shall be calculated from the date of first publication of the advertisement in a newspaper or posting on the web site, as the case may be:
- *Provided that for all procurements up to three million Pakistani Rupees, the response time shall be considered from the date of appearance of the advertisement on the Authority's website.

Secretary, Ministry of Federal Education and Professional Training is requested to notify Projector Director (PMU) to rectify the given mistake and issue corrigendum in accordance with PPRA 2004 to avoid mis-procurement under Rule 50.

Note:

The Authority may disqualify the consultant firms if it is found, at any stage that the information submitted by the firms were false, incorrect or Incomplete. Authority can also take penal action against the firms / Consultants or debar the firms / Consultants for future works
