**Sub: Allegation of Corruption against DMC South for Collusive Bidding to favor
M/S Meraj Limited.**

Dear Sir,

Transparency International Pakistan has received a complaint on 15-08-2016 on the allegation of corruption against DMC South for collusive bidding to favor M/S Meraj Limited.

The copy of the complaint along with annexures is enclosed, which comprise of following main accusations;

1. The prospective fabricators/ manufacturers willing to participate in the tender trying to purchase the tender documents are denied the issuance on one pretext or the other. It is very reliably learnt that verbal orders for the containers to be procured through these tenders are placed on to a company Meraj Limited, Plot No. 11, Sector- 15, Korangi Industrial Area, Karachi, Tel: 3505146, 35050145, 35067020. The fabrication & supply of containers has already begun. It is also learnt/ that advance payment has also been made to the company. The aforesaid tenders appear to be an eye wash to fulfill the required formalities in order to conceal the illegal and corrupt actions of the persons involved.
2. It is also learnt that some departments under the local department like DMCs, etc are also purchasing these containers illegally without any authority and proper tendering. This constitutes an open challenge to the authority and the efforts of the said agencies in combating corruption by the government departments. Your kind self through this communication is called upon to discharge your constitution obligations and duty to thoroughly investigate the matter and take stern action under law against the looters of national wealth.

The Minister is requested to kindly take immediate action. Under SPPRA Rules the tenders are required to be uploaded on SPPRA website, and so that they can be downloaded by bidders, which seem to be compromised by the department and the Minister may kindly take immediate action on this complaint.

Transparency International Pakistan is striving for across the board application of Rule of Law, which is the only way to stop corruption.

The prospective fabricators/ manufacturers willing to participate in the tender trying to purchase the tender documents are denied the issuance on one pretext or the other. It is very reliably learnt that verbal orders for the containers to be procured through these tenders are placed on to a company **MERAJ LIMITED**, Plot No.11, Sector-15, Korangi Industrial Area, Karachi, Tel: 35050146, 35050145, 35067020. The fabrication & supply of containers has already begun. It is also learnt/ that advance

payment has also been made to the company. The aforesaid tenders appear to be an eye wash to fulfill the required formalities in order to conceal the illegal & corrupt actions of the persons involved.

It is also learnt that some departments under the local department like DMCs, etc are also purchasing these containers illegally without any authority & proper tendering. This constitutes an open challenge to the authority and the efforts of the said agencies in combating corruption by the government departments. Your kind self through this communication is called upon to discharge your constitution obligations & duty to thoroughly investigate the matter and take stern action under law against the looters of national wealth.

In the end, I appologise for not disclosing my identity as I donot have a capacity to face this mafia which may physically eliminate or case irreparable damage to any one who come in their way for achievement of their nefarious designs.
