1. The project is run-of-the-river hydropower scheme located on Panjkora River at District Lower Dir of Khyber Pakhtunkhwa Province.
2. The Project is listed as a committed project in the approved IGCEP-2021.
3. The transmission line from the Project to PESCO network for both, the interim and permanent arrangements, will be constructed by PEDO.

  - iii. Whether PESCO or CPPA-G will be responsible for the payment/ settlement mechanism in the instant case?



Where any statement in an affidavit given as per paragraph above is stated to be true according to the information received by the deponent, the affidavit shall also disclose the source of such information.
