

APPROVAL OF CHARGE OF Managing Director (PPRA) POST

1. **Muhammad Zubair Offered Rs.50,000,000/- (5-Crore) to different TOUTS for Grant of MD Post Charge.**
2. Present MD (PPRA) BS-22 an officer of Audit Group transfer to Parent Department. The illegally appointed **CORRUPT Muhammad Zubair, DG BS-20** in PPRA is lobbying to get the charge of **Two Grade above BS-22 Post of Managing Director (PPRA)**. He **Approached PRIME MINISTER OFFICE, CABINET DIVISION, FEDERAL CABINET MEMBERS MNAs, Senators for Approval of MD Charge.**
3. **TWO SEXUAL Cases are Pending (Harassment of Women at Work Place Act 2010) filed by TWO BS-18 Grade FEMALE PPRA Officers** against M. Zubair. He is **nominated Accused** in THREE Pending Investigations in **National Accountability Bureau (NAB)** and THREE Investigations in **Federal Investigation Agency (FIA)**. TWO cases are Pending in **Islamabad High Court** against his illegal appointment. He **Personally involved in MORE THAN 50-CRORE RUPEES CORRUPTION & Corrupt Practices, Misuse of Authority in PPRA since 2018 as Annex-A.**
4. **He is an officer of BS-18 of {PNRA}**. Therefore, his mental level, approach, attitude and caliber is like a BS-18 officer of Engineering Cadre with no ability of running a Management Cadre office. **He also suffers from some psychological disease and lacks emotional stability.**
5. Muhammad Zubair with the help of Ali Temoor DD (PPRA) appointed in PPRA through Placing **BOGUS/FAKE documents and submission of FASLE Particulars at the time of SHORT LISTINGS and Concealment of Facts and Forged the Perjury during whole selection PROCESS.** He does not possess Post Qualification Experience of 17-Years and joined PPRA through irregular manner, without relieving from BS-18 Post from PNRA where he did not clear the security from PNRA, SPD, ISI, MI offices. His appointment as DG PPRA has been challenged in IHC through **WP No.2498/2019 and No.2203/2020 and Contempt case is also filed.**
6. **Mr. Javed Akbar Bhatti, ex-Special Secretary Cabinet Division and Present Deputy Secretary (RA)** have submitted **initial fact finding report** to Secretary, Finance Division/Chairman PPRA Board through Secretary, Cabinet Division on illegal appointment, Misuse of Authority and Corruption of Muhammad Zubair. In this report it has been established that Muhammad Zubair appointment is illegal and he involved in corruption & corrupt practices, misuse of authority, but till date his case did not place in PPRA Board for approval of his removal/dismissal from service orders.
7. **Direct the Secretary Establishment & Cabinet Division not recommend the Muhammad Zubair name for charge of MD (PPRA) and submit the Summary for appointment of FULL Time regular MD (PPRA) immediately and STOP the MNAs & Senators not favour to Zubair in above MD (PPRA) Charge and others illegal matters.**



A Well Organized & Established GANG/MAFIA of illegal Appointed & Promoted Employees of PPRA like as Muhammad Zubair, Muhammad Khurshid, Rizwan Mahmood, Ali Temoor AND Asma Shaheen received Rs.500,000,000/- (50-Crore) from October, 2018 to till date and further planning for more than **50-Crore Rupees** as **Commission, BRIBE/ Kickbacks** in PPRA and Project Matters. **Muhammad Nadeem, Sheharyar Masood, Fiaz Qaiser (PS to MD), Asim Jalil, Zeeshan Siddiqui, Hassan Raza and Muhammad Zakeer** are acting as TOUTS/Front Mans of above officers and dealing corruption cases with different Parties. They are using different relatives and friends Bank Accounts in **UK, Dubai and others Countries** as well as different Pakistani Bank Accounts for handling and receipts of amounts from different parties.**



3.	OGDCL awarded drilling contract against the PPRA rules to Cougar Drilling Solutions Company in Balochistan. NAB conducted inquiry in 2018-2019. He issued clarifications against the PPRA Rules to NAB than NAB closed the inquiry in view of PPRA clarification. NAB without examining legality of that (wrong) clarification closed the case. He thus defrauded the NAB.	50,000,000

He issued and uploaded on PPRA website policy decision letter No. 1(1)/MD/PPRA/2019 dated 09-08-2019 during temporary charge of MD, without approval of PPRA Board, he allowed PEL Company Lahore and others international blacklisted organizations/ companies to take part in the procurement process in Pakistan.	15,000,000
5.	On 14-08-2019 (a public holiday) a day before expiry of his temporary charge of MD (PPRA), he issued instructions without approval of PPRA Board. He issued these instructions to oblige certain persons, firms, suppliers during his stop gap posting, without waiting for regular MD-PPRA on 16.08.2019.	10,000,000
6.	He gave undue favour to certain companies in different tenders of MEPCO. PM office conducted inquiry. All record of inquiry is available in PM Office and Chairman MEPCO office.	10,000,000
7.	He granted exemption to NADRA for five Years procurement contract to a company in 2018 without obtaining approval from Board and without processing case on file.	10,000,000
8.	Received advance amount in a case of PHA-F Housing Scheme KUCJLAK Quetta.	10,000,000
9.	Payment to Hafiz Arafat Ahmed, Chaudhry Advocate Fee without the approval of Law Division against the PPRA Rules.	10,000,000

Subject : Illegal Appointment AND Corruption & Corrupt Practices of Muhammad Zubair, Ali Temoor, M. Khurshid

- A. Mr. Javed Akbar Bhatti ex-Special Secretary Cabinet Division** submitted **facts finding report** to Chairman PPRA Board/Secretary, Finance Division through Secretary, Cabinet Division in May 2019 on illegal appointment, Misuse of Authority and Corruption of Muhammad Zubair, Ali Temoor and others. He proposed suspension of Muhammad Zubair and placing of report in PPRA Board Special Meeting for removal/dismissals of Muhammad Zubair with Board approval. The report of Mr. Javed Akbar Bhatti is available with **Deputy Secretary (RA) Cabinet Division and Addl Secretary Finance (Expenditure) office**. Muhammad Zubair used sources and **MONEY In Prime Minister and different Special Assistants and Advisors to PM Offices**, therefore his fact finding report did not place in PPRA Board till date. Dr. Arshad Mahmood, ex-Addl, Finance Secretary, is well aware about this case.
- B.** Muhammad Zubair security clearance not cleared till date on 20.01.2022. He joined PPRA on 01.06.2018 without obtaining security clearance from SPD, ISI, MI and PNRA, therefore PNRA sent the Muhammad Zubair name for criminal action as absconder to FIA, where he managed the PNRA absconder case and paid Rs.1,000,000/- ONE MILLION as BRIBE to Inspector Malik Sadaqat Ali in FIA Islamabad Zone, who sent the PNRA Absconder case directly to JS (RA) Hassan Mahmood, Cabinet Division. Muhammad Zubair spent Rupees ONE MILLION (Rs.1,000,000/-) in JS (RA) office, where absconder case of Muhammad Zubair MISHANDLED till date and DUMPED.
- C.** Sheryhar Masood is managing the PM Portal and handling the complaints of corrupt officers of PPRA from August, 2019. Asma Shaheen, Fiaz Qaiser (PS to MD), Ali Temoor, Muhammad Khurshid, Sheharyar Mahmood, Muhammad Nadeem, Zeeshan Siddiqui, Hassan Raza, Muhammad Zakeer are the touts of Muhammad Zubair and actively take part in receipt of more than **Rs.50-Crore** as Kickbacks/Commission/Bribe from different companies/Ministries/Pvt contractors from October, 2018 to till date. These corruption cases include blacklisting of firms illegally and issuing of clarifications Advises /report/opinions etc to oblige different procuring agencies/ departments without processing of cases on files and without approval of MD PPRA and Board of Directors (BODs).
- D.** Kindly direct the Secretary Cabinet Division to present the report of Mr. Javed Akbar Bhatti on illegal appointment and corrupt practices of **Muhammad Zubair, Ali Temoor, Muhammad Khurshid** in next Board Meeting of PPRA. The removal or dismissal from services orders of all these Culprits may be issue without any further delay.

SUMMARY

- 1) At Present Muhammad Zubair, Muhammad Khurshid, Ali Temoor, Sheryhar Masood, are handling all the complaints received from Prime Minister Portal and departments. These PPRA officers themselves coordinate & guide the complainants i.e. companies/suppliers/contractors to submit their grievances/ complaints to PPRA through PM Portal for technical opinion & clarifications. These complaints reach directly to above mentioned PPRA officers and they are receiving huge amounts as bribe/commission for providing the desired opinion of the tendering companies (To clear their way to their own favorites contractors).
- 1) Muhammad Zubair, Muhammad Khurshid, Muhammad Tariq Javed Khan, Rizwan Mahmood and Ali Temoor are appointed on the basis of Fake/Bogus Experience Certificates/Informations and against the rules. These officers support the different companies' suppliers/contractors against the Federal Govt, in court cases and provide them their desired replies/comments and resultantly court cases decided against the Federal Govt as they done in WP No.2900/2019 and WP No.3098/2018.
- 2) Muhammad Zubair deleted the names, designation and phone Numbers of all PPRA officers from PPRA Website and this has been done for the reason that they are using the names of supporting staff i.e. Assistants, UDCs, LDCs and N/Q etc as Assistant Director, Dy, Director and Director PPRA, while issuing the letters for clarifications/opinion to save himself from any action against him.
- 3) Muhammad Zubair, DG (PPRA) is not only issuing clarifications/opinions letters against the rules & law, but also without approvals of MD (PPRA) on files with the names, signatures of M&E supporting staff as Assistant Director, Director and Deputy Director from 1st July, 2019 to till date and received More Than 30 Crore Rupees as bribe, kickbacks and as commission from different departments i.e. OGDCL, IESCO, WAPDA different offices, SSGC, SNGPL, PHA, FGHA, Dte of Education, MES (Army, Navy, Airforce), KPT, FBR, and others subordinate officers of Federal Ministries/Divisions.
- 4) Muhammad Zubair is not only shrewd and dishonest but has a dire hunger for authority. He tries to influence everyone in his way using all possible deadly tactics i.e. job/life threats, money/bribery, corruption etc to achieve his abhorrent motives. He used the names of Mr. Kamran Sagheer (Assistant), Owais Ahmad Toru, (Assistant), Qazi Muhammad Saleh Bin Amjad (Stenotypist), Syed Raza Ali Shah (LDC), Muhammad Umair (Stenotypist) in Monitoring & Evaluation (M&E) Wing as Assistant Director, Deputy Director and Director M&E and issued letters with the names of these supporting staff of M&E Wing without any approval on files.
- 5) An Officer of BS-20, Secretariat Group, Mr. Hassan Mahmood, Joint Secretary (RA) Cabinet Division Islamabad received 50-Lacs (5-Million) Rupees till date from Muhammad Zubair, DG (PPRA) and managed the all inquiries and corruption cases against Muhammad Zubair in Cabinet Division. He is receiving Millions of Rupees as Bribe on Monthly Basis.
- 6) Above PPRA officers received More than 50-Crore Rupees from October, 2018 onward as kickbacks/commission/bribe from different Min/Div/Departments/Organizations after issuance of opinions/exemptions/reports clarifications/ evaluations, black listing of firm illegally and cancellation of tender notices of different departments (like JTS & ITS) in OTS Cases against the PPRA Rules. A Case against Muhammad Zubair related with illegal blacklisting of Job Testing Services (JTS) is under process in NAB Islamabad office. Islamabad Testing Services (ITS) also filed case M. Zubair in Civil Court.
