**Sub: Publication of the Contract Agreements on BPPRA Website under Balochistan Public Procurement Rules, 2014, Rule 49**

Dear Sir,

Transparency International Pakistan is monitoring implementation of BPPRA Rule 49 (quoted below), **which requires all procuring agencies to upload contract award agreements along with rates/prices quoted/BOQ on the BPPRA website.**

**49. *Publication of the Award of Contract.* - Within forty-five (45) days of the award of contract, Procuring Agency shall publish on the website of the Authority and on its own website, if such a website exists, the results of the bidding process, identifying the bid through procurement identifying number, if any, and the following information:—**

- a) *Contract Evaluation Report*
- b) *Form of Contract and Letter of Award; and*
- c) *Bill of Quantities or Schedule of Requirement*

Rule 49 has been incorporated with a view that the rates, prices and monthly remuneration of consultants/experts, are to be disclosed on the BPPRA website, whereby public/media/departments can scrutinize any overpriced rate/purchases, by comparing prices for similar procurements of different procuring agencies. According to BPPRA Rule 56 (d), material violation of the Act, rules, regulations, orders, instructions, or any other law relating to public procurement amounts to mis-procurement.

TI Pakistan has noted that almost all the contracts award of various procuring agencies (departments) posted on BPPRA website from 1<sup>st</sup> July 2020 to 25 September 2020, do not include contract nor the BOQ rates. Annex-A.

Similar is the positions of all previous Contracts posted of BRRPA website.

TI Pakistan has also noticed that the Contract Award Section on the BPPRA website is not organized as per the provincial departments.

TI Pakistan requests the MD BPPRA to take action on this violation of Rule 49 by Irrigation department, to ensure compliance of Rule 49 by the irrigation department; as such contracts are deemed mis-procurement under BPPRA Rule 56 (d).
