FOREWARD

Right of Access to Information is a backbone of democracy. Pakistan has come a long way in ensuring that effective Access to Information laws are enacted at the federal and provincial level. The Second generation RTI laws are distinguished from the First generation RTI laws in number of ways including provision of Proactive Disclosure information to the citizens of Pakistan mainly through the websites of public departments.

State of Implementation of Proactive Disclosure Provision – Case Study of Federal Right of Access to Information Act 2017 is an attempt to identify gaps regarding proactive disclosure of information by the Federal Ministries and Departments of the Federal Government, in line with Section 5 of Right of Access to Information Act 2017.

Since May 2020, Transparency International Pakistan has been monitoring the implementation of Proactive Disclosure provisions in the context of federal and provincial RTI laws. In this regard, TI Pakistan has published case studies of Sindh Transparency and Right to Information Act 2016, The Khyber Pakhtunkhwa Right to Information Act 2013 and Punjab Transparency and Right to Information Act 2013.

The current study on Federal RTI Act 2017 finds that the official websites of various important ministries and the departments of the Federal Government disclose only little information. The selected ministries and departments have been studied in the context of 9 clauses of Section 5 of Federal Right of Access to Information Act 2017.

The study provides various recommendations aimed at enhancing the understanding of public bodies of their legal obligation to disclose information to the citizens and the role of the Pakistan Information Commission. It is hoped that the ministries and the federal government departments will use the findings of this research to ensure effective implementation of proactive disclosure as per the Federal Right of Access to Information Act 2017.

INTRODUCTION

BACKGROUND

Access to information plays a pivotal role in fostering transparency and empowering the public to actively participate in matters of governance. In the absence of easily accessible information systems, transparent processes, and comprehensive reporting mechanisms, the conduct, and operations of the main pillars of the state remains out public purview. This vital information is also indispensable for public evaluation of government performance and effective formulation of well-informed, evidence-based policy making. It is imperative that the citizens possess the necessary means to access and review information from the key pillars of the National Integrity System including legislature, executive, judiciary, and public sector, enabling them to competently assess performance and contribute to the decision-making process.

The significance of access to information for sustainable development has been recognized since the adoption of the Rio Declaration in 1992. Additionally, the 2030 Agenda for Sustainable Development, embraced by all 193 UN member states, underscores the importance of access to information as a cornerstone to achieve progress on all 17 SDGs including eradicating poverty, safeguarding the environment, and promoting prosperity for all.

Making information accessible to everyone, regardless of their abilities or circumstances, is crucial. By prioritizing accessibility, society ensures that every citizen can actively participate in decision-making processes and hold government accountable.

Access to information is of utmost importance in fostering transparency and empowering the public. It enables individuals and key stakeholders to evaluate performance, contribute to decision-making processes, and formulate well-grounded policies and plans. Recognized as a human right and an integral aspect of sustainable development, access to information

ensures that no one is excluded and that all citizens can actively participate in shaping their societies and governments.

Right to information and the Constitution of Pakistan:

Constitution of Pakistan under Article 19 and 19-A guarantee Freedom of Speech and Right to Information.

19 Freedom of speech: *Every citizen shall have the right to freedom of speech and expression, and there shall be freedom of the press, subject to any reasonable restrictions imposed by law in the interest of the glory of Islam or the integrity, security or defence of Pakistan or any part thereof, friendly relations with foreign States, public order, decency or morality, or in relation to contempt of court, [commission of] or incitement to an offence.*

19-A. Right to information: *Every citizen shall have the right to have access to information in all matters of public importance subject to regulation and reasonable restrictions imposed by law.*

A BRIEF HISTORY OF RTI LAW IN PAKISTAN

Throughout the history of Pakistan, attempts have been made by various governments to introduce access to information legislation in Pakistan.

The first such attempt was made in 1990, when Jamat-i-Islami senator Professor Khurshid Ahmed tabled a Freedom of Information (FOI) Bill in the Senate. The private bill by the senator failed to be enacted. In 1994, the Public Accounts Committee headed by Senator Malik Qasim drafted a FOI bill, however, due to bureaucratic hurdles it was not enacted. In 1997, during the period of interim government, the Federal Minister of Law Mr. Fakhruddin G. Ebrahim drafted FOI bill which was promulgated through an ordinance. However, it was not enacted by the subsequent government of PML(N) which came into power after the election in 1997. In 2001, Sindh government introduced Sindh local Government Ordinance which enshrined the citizens right to access information. However, its scope was only limited to local government and its departments. In 2002, the President of Pakistan General Pervez Musharraf, through an Ordinance, introduced Freedom of Information laws in the country.¹ By that time, Pakistan became the first country in South Asia which introduced FOI law at the federal level. Though the objective of the law was to provide citizens with access to public information, it could not live up to this expectation. On the other hand, provinces had to introduce their own FOI laws. In 2005, Balochistan was the first province which introduced FOI law in the

province.² Thereafter, Sindh provincial assembly also passed FOI bill in 2006.³ The FOI laws which were enacted at the federal and provincial levels were almost the same. They were considered weak laws having complicated and long process to get the required information, hence, could not gain much traction.

In 2010, Article 19-A was introduced in the Constitution of Pakistan through 18th Constitutional Amendment. Article 19-A acknowledged citizens' right to information as a fundamental right. This paved the way for stronger RTI laws in the country. In 2013, the provincial assembly of Khyber Pakhtunkhwa (KP) passed KP Right to Information Bill 2013.⁴ Same year, Punjab government enacted Punjab Transparency and Right to information Bill 2013.⁵ After KP and Punjab RTI legislation, efforts were further strengthened for replacing weak FOI laws with stronger RTI laws in Sindh and Balochistan province as well as at the federal level. Civil society has played a vital role towards the enactment of second generation, improved RTI laws in Pakistan. In Sindh, CSOs formed a coalition which lobbied, advocated and proposed recommendations to the legislature to introduce stronger RTI law in the Sindh province. In September 2016, the Sindh cabinet approved the draft "Sindh Transparency and Right to Information Bill

2016. In March 2017, Sindh Assembly passed the Sindh Transparency and Right to Information Bill 2016 and introduced a new chapter of public information in the province.⁶ In 2017, the Federal Government also passed Right to Access to Information Act 2017. In February 2021,

the Balochistan Government repealed the ineffective Balochistan Freedom of Information Act, 2005 with an effective Balochistan Right to Information (RTI) Act, 2021 to ensure meaningful participation of citizens in the governance.

A BRIEF TIMELINE OF EFFORTS TO INTRODUCE RTI LAWS IS GIVEN BELLOW

- **1990:** First attempt was made by Professor Khurshid Ahmad, Senator and Naib Amir of Jamaat-i-Islami who tabled a Bill on FOI in the Senate in 1990. This Bill was introduced in the Senate as a private Bill and was forcefully resisted and failed to be enacted.
- **1994:** The Public Accounts Committee, headed by Senator Malik Qasim, made the second attempt in 1994. A Freedom of Information Bill drafted by the committee was forcefully resisted, and therefore, could not be enacted.
- **1997:** A major development occurred towards enactment of FOI legislation when, on the initiative of Fakhruddin G. Ibrahim, the Federal Minister of Law in the Interim Government headed by Malik Mairaj Khalid, the President of Pakistan promulgated a Freedom of Information Ordinance on January 29, 1997. However, the successive government of Mian Nawaz Sharif allowed this Ordinance to lapse and did not enact it into law.
- **2000:** The government of General Pervez Musharraf made public a draft FOI Bill with the aim of soliciting public feedback.
- **2001:** CRCP, a national non-profit organization, proposed a Model Freedom of Information Act to the Government and launched a Campaign on Freedom of Information (FOI-Pakistan).
- **2002:** The President of Pakistan, Gen. Pervez Musharraf, promulgated the Freedom of Information Ordinance on 26th October 2002. It was published in Gazette of Pakistan (Extraordinary) pages 1564-1571 on 26-10-2002 (Ordinance # XCVI Of 2002).
- **2004:** Federal Freedom of Information Rules 2004, SRO: 514(1)/2004 gazetted on 18th June 2004.
- **2005:** Balochistan Freedom of Information Act 2005 published in Balochistan Gazette (Extraordinary) on 6th December 2005 (Balochistan Act # VI of 2005).
- **2007:** Balochistan Freedom of Information Rules 2007, SO (INF:) 2-31/2007/1424- 1524 published on 20th November 2007.

FROM FIRST GENERATION FOI LAWS TO SECOND GENERATION RTI LAWS: A BRIEF COMPARISON

RTI laws can be divided into two categories: First generation and Second generation.

A significant difference exists between the first and second generation Right to Information (RTI) laws. The latter predominantly adhere to the standards of effective RTI legislation, whereas the former either partially comply with these standards or, in numerous instances, contravene them. The First-Generation laws, primarily implemented as a requirement tied to an Asian Development Bank loan, were largely ineffective. On the other hand, the Second-Generation laws have emerged because of effective and persistent advocacy by civil society groups.

EASY PROCESS:

In contrast to the first generation Right to Information (RTI) laws, the second-generation laws, for example: the Khyber Pakhtunkhwa Right to Information Act 2013, the Punjab Transparency and Right to Information Act 2013, Sindh Transparency and Right to Information Act 2016 and the Federal Right to Information Act 2017 have significantly improved the process of accessing information and seeking accountability. These laws have introduced user-friendly and cost-effective mechanisms for filing information requests and registering complaints.

Under the above progressive RTI laws, individuals can submit information requests on plain paper, eliminating the need for complex or specialized forms. Moreover, one notable feature is the removal of any fee associated with filing information requests, making the process more accessible to all citizens. Additionally, the laws stipulate that the first 20 pages of information must be provided free of cost, further facilitating the right of easy access to information.

These enhancements have resulted in a notable shift in the utilization of RTI laws for promoting public accountability. Journalists, civil society groups, and citizens at large have been empowered to exercise their right to information more effectively. They are now able to seek crucial information from the public authorities, holding them accountable for their actions and decisions. By utilizing the provisions of the second generation RTI laws, individuals and organizations can play an active role in scrutinizing government activities, promoting transparency, and demanding good governance.

COMPLAINT REDRESSAL MECHANISMS:

Complaint redressal mechanisms under the second generation RTI laws have proven to be significantly more effective than those outlined in the earlier generation laws. This improvement is primarily attributed to the establishment of an independent and autonomous information commissions, which are entrusted with the responsibility of addressing complaints. These commissions not only have a specific timeframe within which they must make decisions on complaints but are also vested with the authority to impose penalties on officials who unlawfully deny or delay access to requested information.

The inclusion of independent information commissions as part of the second generation RTI laws has brought about a notable enhancement in the accountability and responsiveness of public authorities. By setting specific timeframes for addressing complaints, these commissions ensure that grievances are resolved in a timely manner, reducing any unnecessary delays. Furthermore, their ability to impose penalties on officials who obstruct the right to access information acts as a strong deterrent against non-compliance. It also reinforces the importance of transparency and accountability within government agencies.

Overall, the establishment of independent information commissions under the second generation RTI laws has significantly bolstered the effectiveness of complaints redressal mechanisms. By imposing time limits on complaint resolution and empowering the information commissions with the authority to penalize non-compliant officials, the Second-Generation RTI laws ensure a more robust and responsive system for addressing grievances related to the right to access information.

THE INTERCONNECTION BETWEEN THE RIGHT TO INFORMATION AND GOOD GOVERNANCE

The purpose of the bureaucracy extends beyond mere governance of the country. Bureaucrats bear the responsibility of ensuring the implementation of the promises enshrined in the Constitution for the benefit of the public. The Right to Information (RTI) is a fundamental right that emanates from Article 19-A, which guarantees every citizen access to information pertaining to matters of public importance, subject to regulation and reasonable legal restrictions.

Access to information through the RTI is crucial as it enables citizens to form informed opinions and express themselves. It grants individuals the right to access information that directly impacts their lives and personal freedoms. Unfortunately, political, and bureaucratic elite often control the flow of information to maintain their own power. Consequently, when citizens exercise their right to speak out, it is perceived as a challenge to bureaucratic authority. However, it is imperative that the RTI should not be viewed as an anti-bureaucracy tool. On the contrary, it can serve as a bridge connecting the government and the governed, fostering trust and confidence in the system. The bureaucracy's role extends beyond governance, with bureaucrats being responsible for upholding the commitments made to the public. The Right to Information is a fundamental right that allows citizens to access information and form opinions. It has the potential to foster trust and confidence between the government and its citizens. Furthermore,

the RTI acts as a check on potential abuse of power and corruption within the public sector. By providing a mechanism for citizens to request and obtain information, it helps expose wrongdoing, irregularities, and maladministration. This accountability mechanism ensures that public officials are held responsible for their actions and helps deter corrupt practices.

Effective implementation of the RTI requires a supportive legal framework, institutional mechanisms, and a culture of transparency. Governments must enact robust laws that guarantee the right to information, establish independent oversight bodies, and ensure timely and efficient processing of information requests. Moreover, promoting a culture of transparency and proactive disclosure of information by public authorities can further strengthen the interconnection between the RTI and good governance.

THE ROLE OF MEDIA AND CITIZENS RIGHT TO INFORMATION

The media plays a crucial role in empowering citizens by giving them a voice and providing access to relevant information. It serves as a platform for expressing the needs and aspirations of the people, while also establishing a space for public deliberations on social issues. The influential power of the media in shaping public attitudes, thoughts, and perceptions is vital for citizen engagement in public dialogue.

Media and Right to Information (RTI) laws share a symbiotic relationship that strengthens transparency and accountability in governance. RTI laws empower citizens to access information held by public authorities, enabling them to be well-informed and participate actively in public discourse. In this context, the media plays a crucial role as a catalyst in promoting and facilitating the effective implementation of RTI laws. Media organizations, with their investigative reporting and information dissemination capabilities, serve as key intermediaries between the government, public institutions, and the citizens. They play a

vital role in raising awareness about the existence and significance of RTI laws, educating the public on their rights to access information, and providing support in navigating the process of filing right to information requests. Media scrutiny and reporting through the utilization of RTI laws by citizens and the responsiveness of public authorities contribute to fostering a culture of transparency, accountability, and good governance. By championing the principles of RTI, the media reinforces the importance of public access to information and helps ensure that these laws are effectively utilized for the betterment of society.

PROACTIVE DISCLOSURE

Proactive disclosure represents a paradigm shift in the philosophy behind Right to Information (RTI) laws, emphasizing the release of information even before it is requested. It is envisioned as the future of RTI, where significant public information is made available to the public without citizens making specific inquiries/requests.

Proactive disclosure aligns with the core principles of transparency and accountability, where government departments and agencies take affirmative measures to disseminate information to the public. Rather than solely relying on reactive requests, proactive disclosure recognizes the importance of making information readily accessible to the citizens. Modern technologies have greatly facilitated this process, enabling public agencies to efficiently and timely share information about the government's activities and the matters of governance. By embracing proactive disclosure, governments foster a culture of openness, ensuring that citizens have access to vital information about the government's actions and decisions in a proactive and transparent manner.

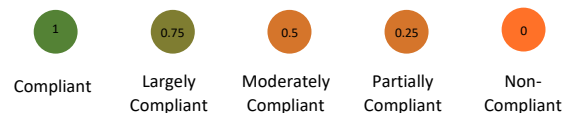
This report focuses on the analysis of 40 federal government departments and ministries websites, specifically examining the status of proactive disclosure implementation. The study employs specific methodology which aligns with the approach used in Transparency International Pakistan's previous assessments of Khyber Pakhtunkhwa (KP) Right to Information Act 2013, Punjab Transparency and Right to Information Act 2013 and Sindh Transparency and Right to Information Act 2016 which assessed the implementation of proactive disclosure provisions in the provincial departments. By utilizing a consistent methodology across different reports, we aim to ensure comparability and continuity in evaluating the progress and effectiveness of proactive disclosure practices.

METHODOLOGY

The objective of this report is to measure the extent to which a public authority proactively discloses public information as per Section 5 of The Right of Access to Information Act, 2017. This assessment report focuses on 9 clauses (a-i) in the section 5 of the Right of Access to Information Act 2017. Each clause/item requires a specific type of information to be disclosed. For this study, we only observed ministries and departments website (similar studies followed the same methodology⁷) and assessed the extent to which the required information is disclosed against each clause/item. The clause/item 'j-l' were exempted from the scope of this study because of their generalization. The law was enacted in 2017 and the study was conducted in April/May 2023, so it is assumed that each department has had enough time to proactively disclose public information under section 5 of the Right of Access to Information Act 2017 through their website.

SCALING

The rating is given on a scale with a minimum score of 0 (non-Compliant) and the maximum score is 1(Compliant). The scale composition is score 0 for non-Compliant, score 0.25 for Partially Compliant, score 0.5 for Moderately Compliant, score 0.75 for Largely Compliant and score 1 for Compliant. Each score is also assigned a color for reporting purpose, which is:



SAMPLE SIZE

A total of 40 websites were checked for the purpose of this study. These websites included key ministries and public departments for which the disclosure of public information is crucial for transparent and accountable governance.

CLAUSES OF PROACTIVE DISCLOSURE

Following are the conditions as mentioned in Section 5 of Proactive Disclosure of The Right of Access to Information Act, 2017. Section 5 has 12 items/clauses, this report has assessed only 9 items/clauses, from (a) to (i) of section 5. The remaining clauses j, k & l are general in nature and hence excluded from the purview of this study.

- a) Description of the public body's organisation and functions, duties, powers and any services it provides to the public, including a directory of its officers and employees,

indicating their duties and functions and their respective remunerations, perks and privileges

- b) statutes, statutory rules, regulations, bye-laws, orders and notifications, etc. applicable to the public body disclosing the date of their respective commencement or effect
- c) substantive or procedural rules and regulations of general application evolved or adopted by the public body, including any manuals or policies used by its employees
- d) relevant facts and background information relating to important policies and decisions which have been adopted, along with a statement of the policies adopted by the public body and the criteria standards or guidelines upon which discretionary powers are exercised by it
- e) the conditions upon which members of the public can acquire any licence, permit, consent, approval, grant, allotment or other benefits of whatsoever nature from any public body or upon which transactions, agreements and contracts, including contracts of employment which can be entered into with the public body, along with particulars about the recipients of any concession, permit, licence or authorisation granted by the public body
- f) a description of its decision-making processes as defined in the Federal Government's Secretariat Instructions, 2004 and any instructions for the time being in force for public to provide input into or be consulted about decisions
- g) detailed budget of the public body, including proposed and actual expenditures, original or revised revenue targets, actual revenue receipts, revisions in the approved budget and the supplementary budget
- h) the methods whereby information in the possession or control of the public body may be obtained and the prescribed fee required along with the name, title and contact details of the designated officials
- i) reports including performance reports, audit reports, evaluation reports, inquiry or investigation reports and other reports that have been finalized
- j) Such other matters which the principal officer of the public body deems fit to be published in the public interest
- k) Such other information as may be prescribed
- l) Camera footages at public places, wherever available. which have a bearing on a crime

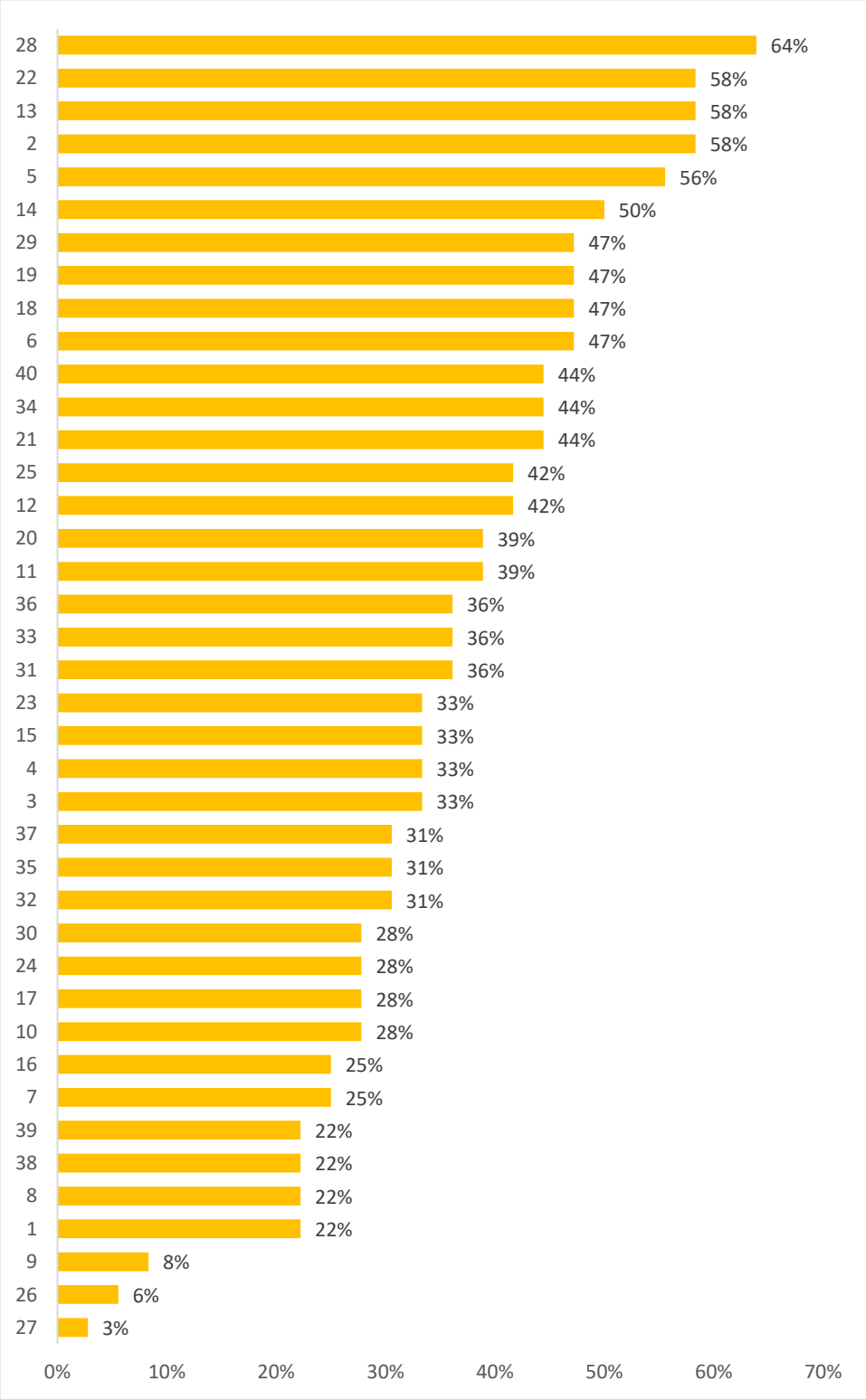

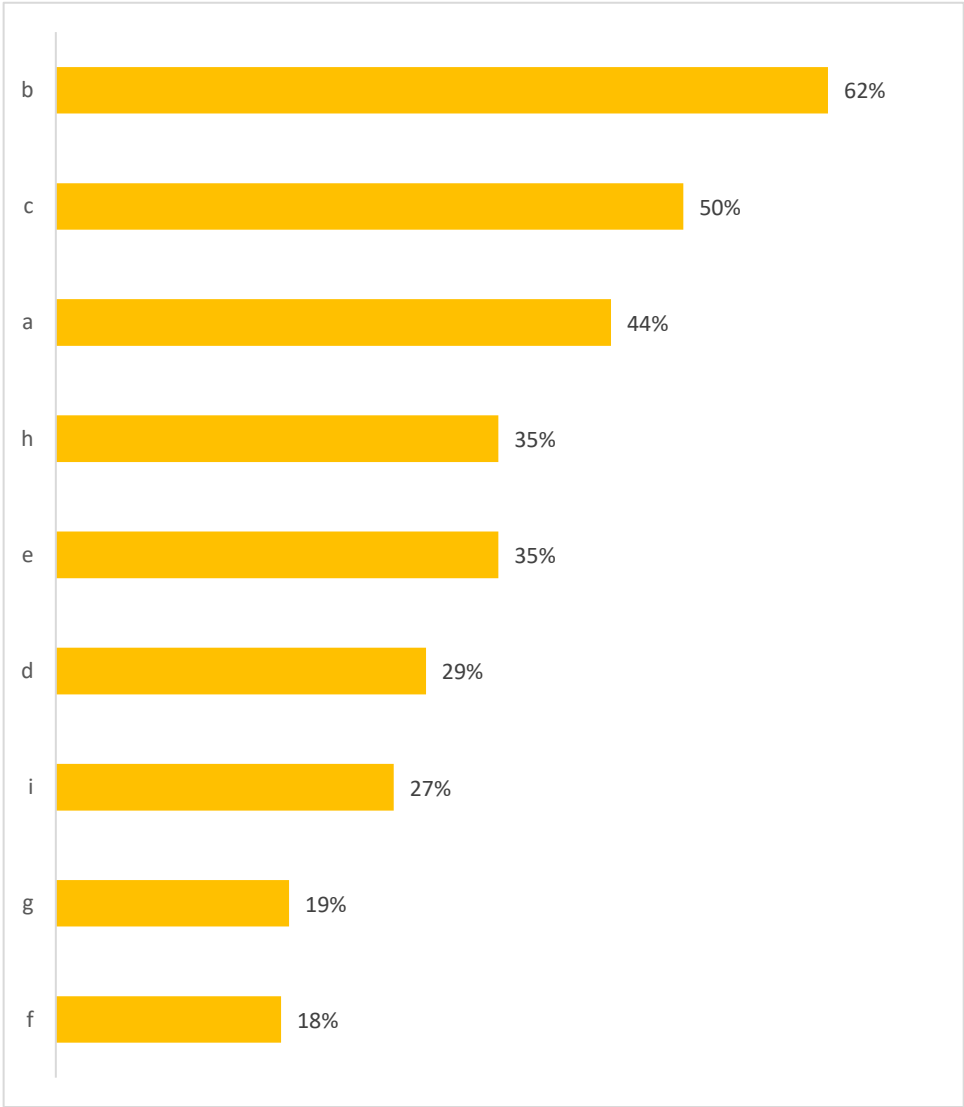

GENERAL OBSERVATION:

MOST OF THE DEPARTMENTS HAVE FAILED TO PROVIDE RELEVANT FACTS AND **BACKGROUND INFORMATION** RELATING TO IMPORTANT POLICIES AND DECISIONS, INFORMATION ABOUT THE DECISION MAKING PROCESS, BUDGET INFORMATION AND THE PERFORMANCE REPORTS.

TI PAKISTAN RECOMMENDATIONS

1. All the departments should have a separate link of Proactive Disclosure that provides complete information in line with the requirements as per the section 5 of the Right of Access to Information Act, 2017.
2. It is observed that there is a lack of understanding about some of the items of section 5, of the Right of Access to Information Act, 2017. The understanding about item f which requires the disclosure of information pertaining to “a description of its decision-making processes as defined in the Federal Government's Secretariat Instructions, 2004 and any instructions for the time being in force for public to provide input into or be consulted about decisions” is not the same across the departments. Since the departments understand it differently, therefore, the required information has not been uploaded. It is recommended that the departments should consult with the Information Commission before uploading information under Proactive Disclosure.
3. Detailed budget of the public body, including proposed and actual expenditures, original or revised revenue targets, actual revenue receipts, revisions in the approved budget and the supplementary budget are not available on the websites of different departments. It is recommended that the departments ensure compliance with item (g) of Section 5, Federal RTI Act 2017.
4. The Information Commission and the departments must arrange adequate training sessions for the respective Public Information Officers / Department Heads about the information required under Section 5 of The Right of Access to Information Act, 2017, so that the requisite information is disclosed in accordance with the law.
5. The Information Commission should take Suo-Moto action and register a complaint against any department which violates Section 5, Proactive Disclosure, of Right of Access to Information Act, 2017.
