Dear Sir,

Transparency International Pakistan received a complaint from Mr. Abdul Waheed Laghari against the violation of SPPRA Rules 2010 in in the tender NIT No. IE/TC/G-55/1977 dated 2012-2021 Sr. No. 3 Construction of Bridge over Mirwah Canal @ RD-260 b/w Deh Jalbani Thari Mirwah. (**Annex-A**)

The complainant has made the following allegations/objections:

That,

1. The sealed bids for 03 works in the tender NIT No. IE/TC/G-55/1977 dated 20-12-2021 were invited by the Executive Engineer Irrigation East Division Khairpur Following tenders were not advertised as per SPRRA Rules.
2. The corrigendum for cancellation of Work No. 3: Construction of Bridge over Mirwah Canal @ RD-260 b/w Deh Jalbani Thari Mirwah was issued by Executive Engineer Irrigation East Division Khairpur Mir vide Corrigendum No. TC/G-55/39 dated 07-01-2022 due to wrong location RD-260 instead of RD-251. (**Annex-B**)
3. On 27-01-2022, the bids were not opened publicly, processed, and the work order was issued to M/s AGK Construction Company.
4. The work was started over Mirwah canal @ RD-260, b/w Deh Jalbani Thari Mirwah, instead of RD-251, and along with surveys were made for illegal construction of road to link the bridge with Thari Mirwah road.
5. The Bid Evolution Report for the construction of bridge over Mirwah Canal @ RD-260 b/w Deh Jalbani Thari Mirwah (ADP No. 1223) was published on SPPRA website. (**Annex-C**)
6. Three bridges with linked roads exist over Mirwah canal within two kilometers between Thari Mirwah and village Haji Muhammad Ismail Laghari. The land where the bridge and road were to be constructed is a disputed land, and the matter is in High Court of Sindh CP. No. D-4105 of 2015. And the construction of road, water course, and above Bridge is to facilitate the land grabbers. (**Annex-D**)

TI Pakistan has examined the complaint, and following are its comments and recommendations.

TI Pakistan Comments:

- a) Based on the authenticity of the submitted documents, prima facie it appears that bids were not opened publicly which is the violation of Rule 28(2) of SPPRA Rules 2010, and this procurement may be declared as Mis-Procurement under Rule 50 of SPPRA Rules 2010.



28(2): All bids shall be opened publicly in the presence of the bidders or their representatives who may choose to be present, at the time and place announced prior to the bidding. The procuring agency shall read aloud the unit price as well as the bid amount and shall record the minutes of the bid opening. All bidders in attendance shall sign an attendance sheet. All bids submitted after the time prescribed shall be rejected and returned without being opened.


- b) The Corrigendum No. TC/G-55/39 dated 07-01-2022 cancelled the Work No. 3 due to wrong location RD-260 instead of RD-251, however, it is noted that the work was started at RD-260, and the procurement was on the wrong road.


TI Pakistan Recommendations:

The bids were invited by publications in the newspapers and Sindh Public Procurement Regulatory Authority Website Vide Tender notice No.IE/TC/G-55/1977 of 2021 Khairpur Mir's dated December 20, 2021 by The Executive Engineer Irrigation East Division Khairpur Mir's. Copy of tender is Attached at "A'.
2. The Corrigendum for cancellation of work at serial No.3 in the above Tender (construction of Bridge over Mirwah

canal @RD-260 B/w Deh Jalbani Thari Mirwah) was issued by Executive Engineer Irrigation East Division Khairpur Mir's Vide his Corrigendum No. TC/G-55/39 of 2022 Khairpur dated January 07, 2022 due to wrong location in the PC-1 @RD-260 instead of RD-251. it was published in English, Urdu, Sindhi newspapers as well as on SPPRA website. Copy is attached at "B".


3. After cancellation of above-mentioned work (construction of Bridge over Mirwah Cannal @RD-260 B/W Deh Jalbani and Thari Mirwah) cancelled Bids were processed, Evaluation of cancelled bids were made and work order was issued to M/s A.G.K Construction Company, who immediately started the construction of Bridge over Mirwah canal @RD-260 B/w Deh Jalbani Thari Mirwah, and along with that, surveys were made for illegal construction of road to link the Bridge with Thari Mirwah road. The Evaluation report of cancelled bids, and issuance of work order against cancelled bids were published on SPPRA website only, the copies of the same are attached at "C" for your legal action against all responsible according to law /Government policy to ensure existence of rule of law.

4. It is evident from Senior Superintendent of Police Khairpur and SHO PS Thari Mirwah reports in C.P.No. D-4105 of, 2015 in the Honorable High Court of Sindh Karachi copies are attached at "D". That, "there is actually dispute between petitioner party and respondent No.4 Sultan Ali Leghari (Addl: Sessions Judge) over a land property", now property has become properties and despite of Honorable High Court orders Sultan Ali Leghari along with his land grabbers are miss-using Government machinery for construction of Roads, Water courses, and Bridges illegally to easily grab opponents / other's properties which will specially multiply tribal enmities, threats to life, honour, prestige, and properties of complainants/residents of Haji Hyder Bux Laghari(Late), who already has submitted their grievances complaint dated March 15, 2022 to the Secretary to Govt. Of Sindh, Irrigation Department, Karachi regarding the above subject matter. Hence, it is humbly submitted that, their already exist Three Bridges with linked roads over Mirwah canal within two Kilometers between Thari Mirwah and village Haji Muhammad Ismial Laghari to facilitate all surrounding villages population, construction

of road, water course, and above Bridge to facilitate above land grabbers may kindly be ceased ones for ever to protect life, honour, prestige, and properties of complainants / residents of Haji Hyder Bux Laghari per Honorable High Court order copies are attached at "D" .

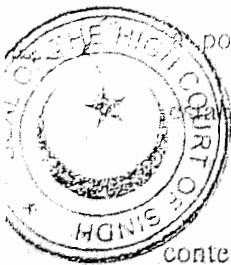

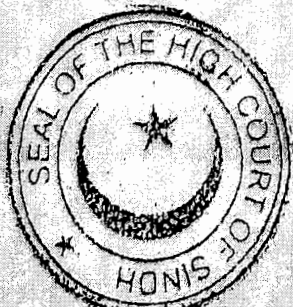

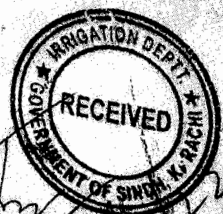
